## **1.0. DEFINITIONS & ABBREVIATIONS**

In this “Bid / RFS Document” the following words and expression will have the meaning as herein defined where the context so admits:

- 1.1. “**Affiliate**” shall mean a company that either directly or indirectly
  - a. controls or
  - b. is controlled by or
  - c. is under common control witha Bidding Company and “**control**” means ownership by one company of at least twenty six percent (26%) of the voting rights of the other company.
- 1.2. “**Applicant for Empanelment/Applicant**” shall mean the company submitting the application for Empanelment.
- 1.3. “**B.I.S**” shall mean specifications of Bureau of Indian Standards (BIS);
- 1.4. “**Bid**” shall mean the Techno Commercial and Price Bid submitted by the Bidder along with all documents/credentials/attachments annexure etc., in response to this RFS, in accordance with the terms and conditions hereof.
- 1.5. “**Bidder/Bidding Company**” shall mean Bidding Company submitting the Bid. Any reference to the Bidder includes Bidding Company / including its successors, executors and permitted assigns as the context may require;
- 1.6. “**Bid Bond**” shall mean the unconditional and irrevocable bank guarantee to be submitted along with the Bid by the Bidder under Clause 3.15 of this RFS, in the prescribed Format- 3;
- 1.7. “**Bid Deadline**” shall mean the last date and time for submission of Bid in response to this RFS as specified in Bid information Sheet;
- 1.8. “**Bid Capacity**” shall means capacity offered by the bidder in his Bid under invitation.
- 1.9. “**CEA**” shall mean Central Electricity Authority.
- 1.10. “**Chartered Accountant**” shall mean a person practicing in India or a firm whereof all the partners practicing in India as a Chartered Accountant(s) within the meaning of the Chartered Accountants Act, 1949;
- 1.11. “**Competent Authority**” shall mean Managing Director (MD) of Solar Energy Corporation of India himself and/or a person or group of persons nominated by MD for the mentioned purpose herein;

- 1.12. **“Commissioning”** means Successful operation of the Project / Works by the Contractor, for the purpose of carrying out Performance Test(s) as defined in RFS.
- 1.13. **“Company”** shall mean a body incorporated in India under the Companies Act, 1956 or Companies Act, 2013 including any amendment thereto;
- 1.14. **“Capacity Utilization Factor” (CUF)** means the ratio of the annual output of the plant in kWh versus installed plant capacity for number of days.  $CUF = \text{plant output in kWh} / (\text{installed plant capacity in kW} * 365 \times 24)$ .
- 1.15. **“Eligibility Criteria”** shall mean the Eligibility Criteria as set forth in Clause 3.6 of this RFS;
- 1.16. **“Financially Evaluated Entity”** shall mean the company which has been evaluated for the satisfaction of the Financial Eligibility Criteria set forth in Clause 3.6.3 hereof;
- 1.17. **“IEC”** shall mean specifications of International Electro-technical Commission;
- 1.18. **“kWp”** shall mean Kilo-Watt Peak;
- 1.19. **“kWh”** shall mean Kilo-Watt-hour;
- 1.20. **“MNRE”** shall mean Ministry of New and Renewable Energy, Government of India;
- 1.21. **“Maximum Bid Capacity”** shall mean 5 MWp which is the maximum capacity for which the Bidder can submit its Bid. ;
- 1.22. **“O&M”** shall mean Operation & Maintenance of Rooftop Solar PV system for 5 years;
- 1.23. **“Owner of the project”** shall mean anyone who has ownership(including lease ownership also) of the roof and is the legal owner of all equipments of the project. Owner of the project can enter into a PPA with the consumer (s) of power for supply of solar power for at least 25 years from the date of Commissioning of project.
- 1.24. **“Project Cost / Project Price” shall** mean the price offered by the Bidder for the Scope of work as per RFS document for a State.
- 1.25. **“Part-A”** Projects which are from 10kWp to 500kWp only.
- 1.26. **“Part-B”** Projects which are less than 10kWp only.
- 1.27. **“Project capacity”** means Capacity in kWp offered by the Bidder for each State consisting of single or multiple roof tops. The project capacity specified is on “DC” output Side only.



- 1.28. **“Performance Ratio” (PR) means**  
“Performance Ratio” (PR) means the ratio of plant output versus installed plant capacity at any instance with respect to the radiation measured.  
 $PR = \frac{\text{Measured output in kW}}{\text{Installed Plant capacity in kW}} \times (1000 \text{ W/m}^2 / \text{Measured radiation intensity in W/m}^2)$ .
- 1.29. **“Parent”** shall mean a company, which holds at least more than 51% equity either directly or indirectly in the Bidding Company or Project Company or a Member in a Consortium developing the Project
- 1.30. **“Project Company”** shall mean Company incorporated by the bidder as per Indian Laws in accordance with Clause no 3.7.
- 1.31. **“Project Sanction Documents”** shall mean the documents as specified in Annexure – A
- 1.32. **“Price Bid”** shall mean Envelope III of the Bid, containing the Bidder’s quoted Price as per the Section- IV of this RFS;
- 1.33. **“Qualified Bidder ”** shall mean the Bidder(s) who, after evaluation of their Techno Commercial Bid as per Clause 3.1 stand qualified for opening and evaluation of their Price Bid;
- 1.34. **“RFS”** shall mean Request for Selection (RFS)/Bid document/Tender document
- 1.35. **“RESCO”** shall mean Renewable Energy Service Companies;
- 1.36. **“RESCO model”** shall mean where the bidders intend to take a roof top owned by some other entity on mutually agreed terms and conditions from the roof top owner(s) and enters into the PPA with rooftop owner / DISCOM / others for supply of Solar power for 25 years from the date of Commissioning of project.
- 1.37. **“Statutory Auditor”** shall mean the auditor of a Company appointed under the provisions of the Companies Act, 1956 or under the provisions of any other applicable governing law;
- 1.38. **“Successful Bidder(s) /Contractor/Project Developers(s)”** shall mean the Bidder(s) selected by SECI pursuant to this RFS Phase-IV-Part 2 for Implementation of Grid Connected Roof Top Solar PV System as per the terms of the RFS Documents, and to whom an Allocation Letter has been issued;

## SECTION - I

### A. INTRODUCTION, BID DETAILS AND INSTRUCTIONS TO THE BIDDERS

#### 1. INTRODUCTION

- 1.1 MNRE launched a pilot scheme for promotion of large scale grid-connected roof top solar PV projects and SECI has been designated as implementing agency for this scheme. The pilot scheme with aggregate capacity of 50 MWp (CAPEX /Part-A-40MW, RESCO /Part-B-10MW) in various states across the country was implemented on open competitive bidding basis by SECI vide RFS.No. SECI/Cont./SRT-IV/70/2014 dated 24-03-2014. 23.5 MWp capacity was awarded to successful bidders under CAPEX and 9MWp was awarded to successful bidders under RESCO. The capacity from previous Phases (I, II & III) is around 5.5MWp. SECI now invites Bid for 23 MWp under CAPEX only.
- 1.2 **Bidder can :**
- Submit bids under CAPEX for the State(s) mentioned in RFS as per Clause 2.1.3. And/or
  - Apply for Empanelment on Pan India basis  
And/or
  - Apply for Empanelment for the States of his choice as per the Covering letter Format-1.
- 1.3 Applicant can also apply for the empanelment without submission of bids for “Bid under CAPEX of this RFS”.

**Please refer Clause 3.4 for Empanelment of applicants and other details for empanelment.**

- 1.4 The pilot scheme targets installation of grid-connected roof top solar PV projects on the roofs of government offices, PSUs, Commercial establishments, hospitals, cold storages, warehouses, industry and educational institutions and private houses. The generated solar power will be utilized for captive application and the surplus power will be fed to the grid. The scheme aims to reduce the fossil fuel based electricity load on main grid and make building self-sustainable from the point of electricity, to the extent possible.
- 1.5 SECI, which expression shall also include its successors and permitted assigns, hereby invites interested companies to participate in the bidding process for the selection of Successful Bidder(s) for implementation of large scale grid-connected roof top Solar Photovoltaic Projects under this pilot scheme in the States indicated herein under.

- 1.6 The Bidder is advised to read carefully all instructions and conditions appearing in this document and understand them fully. All information and documents required as per the bid document must be furnished. Failure to provide the information and / or documents as required may render the bid technically unacceptable.
- 1.7 The bidder shall be deemed to have examined the bid document, to have obtained his own information in all matters whatsoever that might affect the carrying out the works in line with the scope of work specified elsewhere in the document at the offered rates and to have satisfied himself to the sufficiency of his bid. The bidder shall be deemed to know the scope, nature and magnitude of the works and requirement of materials, equipment, tools and labour involved, wage structures and as to what all works he has to complete in accordance with the bid documents irrespective of any defects, omissions or errors that may be found in the bid documents.
- 1.8 For Special category States as mentioned in RFS (J&K , Uttrakhand etc.), subsidy is available @ 15% of L1 project cost quoted by the Successful Bidder for Government as well as Private Roofs.

## 2.0 **BID DETAILS:**

- 2.1 **Bids in Part-A & Part-B (CAPEX Model):** The bidding process under this Phase-IV of Part-2 of the rooftop scheme is for **23 MWp for CAPEX model only and Bidder can apply in any State as tabulated in Clause 2.1.3 below and upto the maximum capacity of 5MWp as per Clause 2.4.2 of RFS.** The Bidder shall apply for 50% of Tendered capacity only for each state indicated in table in Clause 2.1.3. Bidders quoting less than or greater than 50 % of the tendered capacity in that state shall be out-rightly rejected.

2.1.1 Bids are invited from the prospective bidders for the tendered capacity as indicated below against each state based on the Project Cost (CAPEX Model). In this part, bidder will be required to quote the project Cost for each state. Based on Project cost quoted for each state by the Successful Bidders, subsidy @ 15 % of the L1 project cost by the Successful Bidder will be available from SECI to the Successful Bidders for the allocated capacity subject to Clause 6.3.2 of RFS.

2.1.2 **Maximum allowable Project cost** for this Model is at the rate of Rs.80/- per Wp and the bids with project cost (bids for Part-B or Part-A capacity should be less than or equal to Rs 80/Wp) more than Rs.80/- Per Wp will not be considered for evaluation and award.

2.1.3 The States, where the projects are required to be installed along with the respective capacities for each state is indicated in the table below.

**2.3 SIZE OF THE PROJECTS:**

2.3.1 The size of each project shall be in the range of **10kWp to 500 kWp** for commercial / Industrial sector consumers'. However, the projects below 10 kWp may also be considered for residential sector. One project may however comprise of several rooftop units. Each roof top unit can separately connect with the grid and may have separate meters.

2.3.2 Further, Successful bidders to whom letter of allocation has been issued will be allowed to submit single proposal for an aggregate capacity not less than 50kWp for approval and issue of sanction letter by SECI. Single sanction letter will be issued for the total aggregate capacity submitted by the bidder for approval as per above .However, at sole discretion of SECI, less than 50kWp project proposal may also be considered for sanctioning.

## 2.4 BID CAPACITY

2.4.1 **Bids shall be submitted for 50% of Tendered capacity only for each state indicated in table in Clause 2.1.3.** Bids quoting less than or greater than 50 % of the tendered capacity (Part-A and Part-B) in that state shall be out-rightly rejected. Each Successful Bidder shall be allocated 50 % of the Part-B capacity and 50 % of the Part-A capacity as per capacity indicated in table in Clause 2.1.3. Bidder shall quote in its price bid the capacities accordingly. Price bids quoted by the bidder having less than or greater than 50 % of the tendered capacity for Part-A and Part-B in that state shall be out-rightly rejected.

**For example:** If a Bidder wishes to apply in the State Delhi then bidder shall quote for 1.5MWp with 1.125MWp for Part-A capacity and 375kWp for Part-B capacity. Bids quoting less than or greater than 50 % of the tendered capacity for Part-A and Part-B in that state shall be out-rightly rejected.

2.4.2 However, a Bidder can apply and is eligible to apply for a maximum capacity of 5 MWp for the states indicated under CAPEX model only. Offer of the Bidders quoting cumulative capacity more than 5MWp shall be out rightly rejected.

2.4.3 In exceptional circumstances and at sole discretion of SECI, unutilized capacity of State(s) (during initial allocation only) can be transferred to other State(s) having demand in excess of declared capacity and total capacity of the State(s) after transfer can be awarded to more than two bidders in a State equally at L1 price only. The allocation of capacity to a State shall start from the state where lowest bid is received and response is also higher than the tendered capacity in the state. For other states, allocation shall be done in the ascending order of the lowest bid received as per above subject to maximum allocation of 5 MWp to a bidder.

2.4.3.1 SECI reserves the right to allocate part capacity also subject to acceptance of the bidder.

## 3 INSTRUCTIONS TO THE BIDDERS

3.1 Bidder must meet the eligibility criteria independently as a Bidding Company or as a Bidding Consortium with one of the members acting as the Lead Member of the Bidding Consortium.

- a. Bidder will be declared as a Qualified Bidder based on meeting the eligibility criteria and as demonstrated based on documentary evidence submitted by the Bidder in the Bid.
- b. In case of a Bidding Consortium the Financial Eligibility criteria like Annual turnover or Net worth as indicated in Clause 3.6.3, shall be fulfilled by the Lead Member or Parent Company of the Lead Member while the Technical Eligibility Criteria shall be fulfilled by consortium member.
- c. In case bidder submitting bid through consortium, a Consortium Agreement as per the Format-10 shall be furnished along with the bid.
- d. Financial Consortium is not allowed in this Bidding Process. Consortium is only permitted for Technical partnership as per Format- 10.
- e. Further in-case where the bidding company has used the financial eligibility criteria of its parent company then it needs to be ensured that any change in the controlling equity of the Bidding company requires prior approval of SECI.
- f. All members of the consortium should be registered as company only. However, Member of the Consortium may form the Project Company as specified in Clause 3.7.
- g. Bidder including its member of the consortium can submit one bid only.

### **3.2 USE OF TECHNICAL AND/OR FINANCIAL STRENGTH OF PARENT COMPANY**

- 3.2.1 Bidder and/or “Applicant for empanelment” can however use the technical and financial strength of its Parent Company or Affiliate to fulfil the Technical and/or Financial Eligibility criteria mentioned below. Members of consortium can also use the credentials of the parent company or Affiliate to fulfil the eligibility requirement.
- 3.2.2 In above case, Bidders/applicants shall submit an Undertaking from the Parent Company as per Format- 9 and also furnish a certificate of relationship of Parent Company or Affiliate with the Bidding Company as per Format-8. Company Secretary Certificate towards shareholding pattern of the Parent Company and the Bidding Company along with a Board resolution from the Parent Company shall also be submitted.
- 3.2.3 Only Technical consortium is allowed for submission of Bids and application for Empanelment.

### **3.3 Void**

### **3.4 APPLICATION FOR EMPANELMENT**

Applicants/ Bidders Qualified for the State will be empanelled by SECI for the State for an initial period of 1 year from the date of notification on SECI website which can be further extended, at the sole discretion of SECI.



### 3.4.1 Applicant /Bidders can

- a. give the option on the covering letter(format-1) expressing their interest for getting empanelled with SECI on Pan India basis  
And/ or
- b. give the option on the covering letter(format-1) expressing their interest for getting empanelled with SECI in the State(s) only of his choice.

Bidder/applicant will be considered empanelled only, if the option has been given with the required documents and processing fee for empanelment.

3.4.2 The Technical eligibility & General eligibility criteria for the empanelment is same as given under Clause 3.6.1 & 3.6.2 of RFS. Maximum capacity in MWp for which Applicants is eligible for empanelment can be calculated as per the Clause 3.6.3 of RFS.

3.4.2.1 No applicant will be considered empanelled having lesser Annual turnover/Net-worth required for the minimum capacity of 250kWp .Please refer Clause 3.6.3 for details of calculation of Annual turnover and Net-worth.

3.4.2.2 SECI reserves the right to add the list of empanelled applicants as per the eligibility criteria mentioned in Clause 3.6 below.

3.4.2.3 SECI reserves the right to remove the names from the list of empanelled applicants as per the bidder performance against the SECI requirements.

#### **For Example:**

- a. If the bidder has the maximum Annual turnover in any of last three financial year as 1.25 Crores (for calculation clause 3.6.3 should be referred) than he will considered empanelled to bid for 250 kWp only.
- b. If the bidder has the maximum Annual turnover in any of last three financial year as 10 Crores (for calculation clause 3.6 should be referred) than he will considered empanelled to bid for 2MWp only.

Or

If the bidder has the Net-worth in the last financial year immediately preceding the Bid Deadline as 6 Crores (for calculation clause 3.6 should be referred) than he will considered empanelled to bid for 2MW only.

3.4.3 SECI reserves the right to cancel the empanelment process or empanelment of the bidders.

3.4.4 **Applicant shall submit non- refundable processing fee in the form of DD for the amount of Rs. 16,854/-** (Rs. Sixteen Thousand Eight Hundred Fifty Four only) inclusive of Service tax only in the Envelope-I along with the Covering letter.

- a. No interest on the processing fee shall be paid to the Applicants.

- b. Fresh applications fulfilling the eligibility requirement as per Clause 3.6 can also be considered for invitation in future at the sole discretion of SECI.

#### 3.4.5 Allocation of unallocated/additional capacity to the empanelled companies on State basis:

SECI at its sole discretion can allocate/sanction the unutilized capacities subject to Clause 2.4.3 above and can allocate/sanction the additional capacities to the empanelled companies with the following methodology:

- a. In such cases, the details of the remaining capacity under each State and the L1 price of that State will be notified through SECI website for information to all the empanelled companies of the State(s). All empanelled companies for every State(s) within 10 days from the date of notification on SECI website or against individual intimation shall give their consent along with the Bid bond of equivalent amount to SECI for execution of the notified capacity at L1 rate of the State they are interested.
- b. In case of more than one such response is received expressing their consent to match the L1 price and to execute the capacity in the State then the preference shall be given in the ascending order of the bid quoted by the bidder. ie first preference will be given to L1 then L2 then L3 and so on until entire capacity is allocated.

Even if, capacity remain unallocated thereafter then;

- c. preference shall be given to qualified and other empanelled company of the State in the alphabetical order of their names subject to matching of L1 price of the State.

Even if, capacity remain unallocated thereafter then;

- d. preference shall be given to qualified and other empanelled company which are empanelled on pan India basis in the alphabetical order of their names subject to matching of L1 price of the State.
- e. If the capacity has been allocated to any qualified bidder/empanelled company then next qualified bidder/empanelled company subject to matching of his L1 price shall be given capacity allocation. The intent is to give chance to all the empanelled companies of the state for capacity allocation subject to their available capacity & matching of L1 price of the State. Above methodology shall be adopted every time when requirement is felt by SECI for capacity allocation. SECI at its sole discretion can entertain business proposals of the empanelled company for capacity allocation.

Even if, capacity remain unallocated then SECI reserves the right to decide further course of action like inviting bids etc from the empanelled companies on pan india basis, if required.

### **3.4.6 Allocation of unallocated /additional capacity to the empanelled companies on PAN India basis**

- I. Empanelled bidders on PAN-India basis shall be utilized only for inviting bids in addition to methodology adopted in clause 3.4.5 (d) above
  - a. When bids are not received in any State of the RFS as per Clause 2.1.3. And/or
  - b. When requirement is felt by SECI in the State(s) other than mentioned in the Clause 2.1.3 of RFS for capacity allocation. And/or
- II. When there is only one qualified and empanelled bidder in the State and none of the qualified bidder matches the L1 price, then above methodology will be adopted as defined in clause 3.4.5(d) above.
- III. Bids can be invited from CAPEX / RESCO/any roof top scheme from the Empanelled companies on PAN-India basis, if required by SECI in future.

3.5 Empanelled companies whether State basis or Pan –India basis would be eligible to participate in both Capex and RESCO bids invitation, if required by SECI in future.

### **3.6 ELIGIBILITY CRITERIA**

#### **3.6.1 GENERAL**

- (a) The Bidder should be either a body incorporated in India under the Companies Act, 1956 or 2013 including any amendment thereto and engaged in the business of Solar Power.

**A copy of certificate of incorporation shall be furnished along with the bid in support of above.**

#### **3.6.2 TECHNICAL ELIGIBILITY CRITERIA:**

The Bidder should have installed & commissioned at least one Grid connected Solar PV Power Project having a capacity of not less than 50 kW which should have been commissioned at least six months prior to Techno-Commercial Bid Opening date. The list of project commissioned at least 6 months prior to Techno-Commercial Bid Opening date, indicating whether the project is grid connected, along with a copy of the Commissioning certificate and Work order / Contract / Agreement/ from the Client/Owner shall be submitted in support of Clause 3.6.2 above.

#### **3.6.3 FINANCIAL ELIGIBILITY CRITERIA:**

- (a) The Bidder should have an Annual Turnover or Net worth as indicated below.

- i. The Annual turnover of Rupees 5.0 Crore per MW in any one of the last 3 financial years preceding the Bid Deadline subject to the condition that the Bidder should at least have completed one financial year.

**OR**

- ii. Net worth equal to or greater than the value calculated at rate of Rs. 3.00 Crore per MW of capacity offered by the Bidder in its Bid. The Computation of Net worth shall be based on unconsolidated audited annual accounts of the last financial year immediately preceding the Bid Deadline. Share premium can be included in the Net-worth calculation in case of listed companies in India only.

In case of more than one Price Bid submitted by the Bidder, the financial eligibility criteria must be fulfilled by such Bidder for the sum total of the capacities being offered by it in its Price Bid.

In case quoted Bid capacity is less than 1 MW, Annual Turnover/Net worth requirements shall be on pro-rata basis.

The formula of calculation of net-worth shall be as follows:

Net-worth = (Paid up share capital) + {(Free reserves - Share premium) + Share premium of listed companies} - (Revaluation of reserves)-(Intangible assets) - (Miscellaneous expenditure to the extent not written off and carry forward losses).

For the purposes of meeting financial requirements, only unconsolidated audited annual accounts shall be used. However, audited consolidated annual accounts of the Bidder may be used for the purpose of financial requirements provided the Bidder has at least twenty six percent (26%) equity in each company whose accounts are merged in the audited consolidated accounts and provided further that the financial capability of such companies (of which accounts are being merged in the consolidated accounts) shall not be considered again for the purpose of evaluation of the Bid.

Bidders shall furnish documentary evidence as per the **Format -7**, duly certified by Authorized Signatory and the Statutory Auditor / Practising Chattered Accountant of the Bidding Company in support of their financial capability.

### **3.7 INCORPORATION OF A PROJECT COMPANY**

- 3.7.1 In case the Bidder wishes to incorporate a Project Company, in such a case, Bidder if selected as a Successful Bidder can incorporate a Project Company. Bidder shall be responsible to get all clearance required/obtained in the name of the Bidding Company transferred in the name of the Project Company.

3.7.2 The aggregate equity share holding of the Successful Bidder in the issued and paid up equity share capital of the Project Company shall not be less than fifty one percent (51%) up to a period of two(2) years from the date of commissioning of the entire Sanctioned Capacity of the Project Developer.

### **3.8 BID SUBMISSION BY THE BIDDER**

3.8.1. The information and/or documents shall be submitted by the Bidder as per the formats specified in Section-IV & Section V of this document.

3.8.2. Strict adherence to the formats wherever specified, is required. Wherever, information has been sought in specified formats, the Bidder shall refrain from referring to brochures /pamphlets. Non-adherence to formats and / or submission of incomplete information may be a ground for declaring the Bid as non-responsive. Each format has to be duly signed and stamped by the authorized signatory of the Bidder.

3.8.3. The Bidder shall furnish documentary evidence in support of meeting Eligibility Criteria as indicated in Clause no. 3.6.1, 3.6.2 and 3.6.3 to the satisfaction of SECI and shall also furnish unconsolidated/consolidated audited annual accounts in support of meeting financial requirement, which shall consist of balance sheet, profit and loss account, profit appropriation account, auditors report, etc., as the case may be of Bidding Company or Financially Evaluated Entity for any of the last three(3) financial years immediately preceding the Bid Deadline which are used by the bidder for the purpose of calculation of Annual Turnover or of last Financial Year in case of Net Worth.

3.8.4. In case the annual accounts for the latest financial year are not audited and therefore the bidder cannot make it available, the applicant shall give certificate to this effect from their directors. In such a case, the Applicant shall provide the Audited Annual Reports for 3(Three) years preceding the year or from the date of incorporation if less than 3 years for which the Audited Annual Report is not being provided.

### **3.9. BID SUBMITTED BY A BIDDING COMPANY :**

The Bidding Company should designate one person to represent the Bidding Company in its dealings with SECI. The person should be authorized to perform all tasks including, but not limited to providing information, responding to enquires, signing of Bid etc. The Bidding Company should submit, along with Bid, a Power of Attorney in original (as per Format-6), authorizing the signatory of the Bid.

### **3.10. CLARIFICATIONS AND PRE-BID MEETING**

3.10.1. The SECI will not enter into any correspondence with the Bidders, except to furnish clarifications on RFS Documents, if necessary. The Bidders may seek clarifications or suggest amendments to RFS in writing, through a

letter or by fax (and also soft copy by e-mail) to reach SECI at the address, date and time mentioned in Bid information sheet.

3.10.2. The Bidder(s) or their authorized representative(s) is /are invited to attend pre-bid meeting(s), which will take place on date(s) as specified in Bid information sheet, or any such other date as notified by SECI.

3.10.3. The purpose of the pre-bid meeting will be to clarify any issues regarding the RFS including in particular, issues raised in writing and submitted by the Bidders.

3.10.4. SECI is not under any obligation to entertain/ respond to suggestions made or to incorporate modifications sought for.

### 3.11. **AMENDMENTS TO RFS BY SECI.**

3.11.1. At any time prior to the deadline for submission of Bids, the SECI may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, modify the RFS document by issuing clarification(s) and/or amendment(s).

3.11.2. The clarification(s) / amendment(s) (if any) may be notified on SECI website [www.seci.gov.in](http://www.seci.gov.in) at least Two (2) days before the proposed date of submission of the Bid. If any amendment is required to be notified within Two (2) days of the proposed date of submission of the Bid, the Bid Deadline may be extended for a suitable period of time.

3.11.3. SECI will not bear any responsibility or liability arising out of non-receipt of the information regarding Amendments in time or otherwise. Bidders must check the website for any such amendment before submitting their Bid.

3.11.4. In case any amendment is notified after submission of the Bid (prior to the opening of Techno-Commercial Bid. Bids received by SECI shall be returned to the concerned Bidders on their request through registered post or courier and it will be for the Bidders to submit fresh Bids as the date notified by the SECI for the purpose.

3.11.5. All the notices related to this Bid which are required to be publicized shall be uploaded on [www.seci.gov.in](http://www.seci.gov.in).

### 3.12. **BIDDING PROCESS**

#### 3.12.1. **BID FORMATS**

3.12.1.1. The Bid in response to this RFS shall be submitted by the Bidders in the manner provided in Clause 3.6 & Clause 3.12.1.1. The Bid shall comprise of the following:

**(A). ENVELOP- I (COVERING LETTER, BID PROCESSING FEE, BID BONDS AND BIDDER FORMAT EXCEL SHEET)**

- i. Covering Letter indicating the Capacity quoted for each State as per the prescribed Format-1.

- ii. Copy of PAN and TAN certificates of Bidding company.
- iii. Bid processing fee @ Rs. 16,854/- for each State calculated in the manner as illustrated below:

**For example No-1:** In case Bidder is quoting for (3) States, then he shall furnish Processing fee of Rs. 50,562/- (Rs. 16,854/- Per State x 3 States) irrespective of capacity of the state. However, processing fee for which the bids are being submitted by the bidder may be consolidated and a single DD may be furnished.

Further, if the Bidder also wishes for the empanelment on Pan India basis and or for the State of his choice other than the State(s) where bidder is submitting bid, then bidder will be required to submit:

- a. Non- refundable processing fee of **Rs. 16,854/-** (Rs. Sixteen Thousand Eight Hundred Fifty Four only) inclusive of Service tax in the form of DD (Demand Draft) for the empanelment separately.

**Note:** Non- refundable processing fee of **Rs. 16,854/-** (Rs. Sixteen Thousand Eight Hundred Fifty Four only) inclusive of Service tax in the form of DD (Demand Draft) shall be submitted by the applicant applying for the empanelment only.

- iv. Bid Bond, as per the prescribed Format-3 shall be submitted separately for each State for the offered capacity in a separate envelop as per Clause 3.15.
- v. Checklist for Bank Guarantee submission requirements as prescribed in Format- 5
- vi. Bidder shall enclose the CD/DVD containing the excel format “Bidder Format .xlsx” of Format 2, Format-A, Format-7 & Format-8 only. Name of the bidding company along with RFS No. shall be superscribed on CD/DVD also. Bidder shall download the excel sheet of above formats from the SECI website [www.seci.gov.in](http://www.seci.gov.in). If there is any difference in the information furnished in duly signed hard copy of above formats and excel sheet then information containing in hard copy of formats will be considered final. (Format will be uploaded on SECI website shortly)

**Note:** All formats and relevant documents as required in the RFS shall be spiral bounded and should be flagged separately. Details of flag should be mentioned in the covering letter.

#### **(B). ENVELOP- II TECHNO-COMMERCIAL DOCUMENTS**

- i. Original power of attorney issued by the Bidding Company in favour of the authorized person signing the Bid, in the form attached hereto as Format-6 or standard power of attorney in favour of authorized person signing the Bid. **(Power of Attorney must be supplemented by Board Resolution to above effect for the company).** However, SECI may accept general Power of Attorney executed in favour of Authorised signatory of the Bidder, if it shall

conclusively establish that the signatory has been authorized by the Board of Directors to execute all documents on behalf of the Bidding Company.

- ii. General particulars of bidders as per Format-2
- iii. Shareholding certificate signed by the company secretary of the bidding company and shareholding certificate signed by the company secretary of the Parent company (if parent company credentials are used).
- iv. Document in support of meeting Eligibility Criteria as per Clause no. 3.6.1 & 3.6.2.
- v. Certificates of incorporation of Bidding company and parent company(if parent company credentials are used)
- vi. Certificates of incorporation of bidding consortium, if technical consortium is envisaged in the bid submitted by bidder.
- vii. Details for meeting Financial Eligibility Criteria as per Clause no. 3.6.3 in the prescribed Format-7 along with documentary evidence for the same.
- viii. If credentials of Parent company are being used by the Bidding company/lead member of the bidding consortium than Format 8 shall be furnished.
- ix. Undertakings from the Financially Evaluated Entity or its Parent Company /Ultimate Parent Company as per Format-9.
- x. Board Resolution of the Parent Company /Ultimate Parent Company of the Bidding company duly certified by the Company Secretary to provide the Performance Bank Guarantee (PBG) in the event of failure of the Bidding Company to do so.
- xi. Board resolution for Authorised signatory
- xii. Signed and stamped Copy of RFS Documents including amendments & clarifications by Authorised signatory on each page.

**(C) ENVELOPE III- PRICE BID(S) AS PER SECTION-IV FOR BID SUBMISSION UNDER CAPEX**

The Bidder shall inter-alia take into account the following while preparing and submitting the Price Bid duly signed by an authorized signatory.

- i.) The Bidder shall submit sealed Price Bid(s) for each State separately in the **Format B**. Each envelope shall be superscripted as "Price Bid for ....MW capacity for .....State .All the Price Bids shall be put in Envelope-III.

### 3.13. VALIDITY OF BID

3.13.1. The bid and the Price Schedule included shall remain valid for a **period of 12 months** from the date of techno-commercial bid opening, with bidder having no right to withdraw, revoke or cancel his offer or unilaterally vary the offer submitted or any terms thereof. In case of the bidder revoking or cancelling his offer or varying any term & conditions in regard thereof or not accepting letter of allocation, SECI shall forfeit the Bid Bond furnished by him. *Confirmation regarding the Bid offer validity shall be clearly mentioned in the covering letter.*

3.13.2. In exceptional circumstances when letter of allocation is not issued, the SECI may solicit the Bidder's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing. The Bid Bond provided under Clause 3.15 shall also be suitably extended. A Bidder may refuse the request without forfeiting its Bid Bond. A Bidder granting the request will neither be required nor permitted to modify its Bid in any manner.

### 3.13.3. Void

### 3.13.4. METHOD OF BID SUBMISSION

3.13.4.1. Bids are required to be submitted in a single sealed cover envelope containing Envelope-I (Covering letter, Processing fee and Bid Bonds) ,Envelope-II (Techno-Commercial documents) and Envelope III (Price Bid for CAPEX) each one duly sealed separately. Envelope should contain the documents as detailed in Clause 3.12 above.

3.13.4.2. In case the Bidder is offering capacity in more than one State under CAPEX, the Price Bid for each State should be sealed in separate envelope and these envelopes shall be placed in Price bid Envelope.

3.13.4.3. All the three envelopes shall be kept in a outermost Envelope. All the envelopes should be superscribed as **“Bid and / or Empanelment for Implementation of Grid connected Roof Top Solar PV System Scheme in Selected States in India Phase-IV-Part-2” (Strikeout whichever is not applicable) – \_\_\_\_\_ Envelope-I (Covering envelope) / Envelope-II (Techno-Commercial Bid) / Envelope-III (Price Bids) along with the “BID DUE DATE”.**

- 3.13.5. The Bidders have the option of sending their Bid either by registered post; or speed post; or courier; or by hand delivery, so as to reach SECI by the Bid Deadline. Bids submitted by telex/telegram/fax/e-mail shall not be considered under any circumstances. SECI shall not be responsible for any delay in receipt of the Bid. Any Bid received after the Bid Deadline shall be returned unopened. *It should be noted that except Envelope III, no other envelope shall contain any information/document relating to Price Bid.* SECI shall not be responsible for premature opening of the Price Bids in case of non-compliance of above.
- 3.13.6. All pages of the Bid, except for the Bid Bond, and any other document executed on non-judicial stamp paper, forming part of the Bid and corrections in the Bid, if any, must be signed by the authorized signatory on behalf of the Bidder. It is clarified that the same authorized signatory shall sign all pages of the Bid. However, any published document submitted with the Bid shall be signed by the authorized signatory at least on the first and last page of such document Bidders shall submit the Bid in original, duly signed by the their authorized signatory of the Bidder. No change or supplemental information to a Bid will be accepted after the Bid Deadline, unless the same is requested for by SECI.
- 3.13.7. If the outer cover envelope or Envelope I (Covering Envelope) or Envelope-II (Techno-Commercial Envelope) Envelope III (Price Bids) is/are not closed/sealed and not superscribed as per the specified requirement, SECI will assume no responsibility for the Bid's misplacement or premature opening.
- 3.13.8. All the envelopes shall be sealed properly & shall indicate the Name & address of the Bidder. The Bid must be complete in all technical and commercial respect and should contain requisite certificates, drawings, informative literature etc. as required in the Bid document. Each page of the Bid document should be signed & stamped. Bids with any type of change or modification in any of the terms/ conditions of this document shall be rejected. If necessary, additional papers may be attached by the Bidder to furnish/ submit the required information. Any term / condition proposed by the Bidder in his bid which is not in accordance with the terms and conditions of the RFS document or any financial conditions, payment terms, rebates etc. mentioned in Price Bid shall be considered as a conditional Bid and will make the Bid invalid.
- 3.14. **COST OF BIDDING**
- 3.14.1. The bidder shall bear all the costs associated with the preparation and submission of his offer, and the company will in no case be responsible or liable for those costs, under any conditions. The Bidder shall not be entitled to claim any costs, charges and expenses of and incidental to or incurred by him through or in connection with his submission of bid even though SECI may elect to modify / withdraw the invitation of Bid.

### 3.15. **BID BOND**

**The Bidder shall furnish the Interest free Bid Bond @ Rs.15.00 Lakhs (Rupees Fifteen Lakhs only) per MWp** in the form of Bank Guarantee (BG) / Demand Draft drawn in favour of “Solar Energy Corporation of India”, payable at New Delhi. The initial validity of Bid Bond shall be for a period of **6 months from the Bid Deadline**, which shall be extended by the bidder as per the bid validity. If the bidder fails to extend the bid bond validity as per above on request by SECI then entire Bid bond may be forfeited. The Bid Bond of unsuccessful bidders shall be returned within 30 days from the date of issue of Letter of Allocation(s) to successful bidders. **Separate Bid Bond shall be furnished for each State.** Bidders submitting Bid Bond Amount less than that required for “50 % of the tendered capacity” under CAPEX than Bid for that state shall not be considered.

The formula applicable to calculate the Bid Bond amount under CAPEX will be:

- a) Bid Bond amount = (Rs. 15.00 Lakh) X Bid Capacity in MWp

Example: Participating for 1.5 MWp, the bidder has to submit Bid Bond of Rs. 15.00 Lakh x 1.5 MWp = Rs. 22.5.00 Lakh (Rupees Twenty Two Lakhs Fifty Thousand Only).

Or

Example: Participating for 500kWp, the bidder has to submit Bid Bond of Rs. 15.00 Lakh x 500/1000 MWp = Rs. 7.5 Lakh (Rupees Seven Lakhs Fifty Thousand Only).

3.15.1. The Bid Bond shall be denominated in Indian Rupees and shall:

- i. at the Bidder’s option, be in the form of either a demand draft, or a bank guarantee from a List of banks as given in Annexure-B
- ii. be confirmed for payment by the branch of the bank giving the bank guarantee at New Delhi.
- iii. be submitted in its original form; copies will not be accepted; and remain valid for a minimum period of 6 months from the date of Techno Commercial bid opening, or beyond any period of extension subsequently requested under Clause 3.13.2.

3.15.2. the Successful Bidder shall sign and stamp the Allocation Letter and return the duplicate copy of the same to SECI within 30 days from the date of its issue.

3.15.3. The Bid Bond shall be forfeited without prejudice to the Bidder being liable for any further consequential loss or damage incurred to SECI under following circumstances:

- a. Hundred percent (100%) of Bid Bond amount, if a Bidder withdraws/revokes or cancels or unilaterally varies his bid in any manner during the period of Bid Validity specified in the RFS document and in accordance with the Clause 3.13.
- b. Hundred percent (100%) of the Bid Bond amount, if the Successful Bidder fails to unconditionally accept the Allocation letter within 15 days from the date of its issue.
- c. Hundred percent (100%) of the Bid Bond amount, if the Successful Bidder fails to furnish the "Performance Security" as per the Clause 3.16.

**3.16. PERFORMANCE SECURITY/PERFORMANCE BANK GUARANTEE (PBG)**

3.16.1. Within 30 days from the date of issue of Allocation letter, Successful Bidder shall furnish the Performance Security calculated in the same manner as Bid Bond amount for the allocated capacity only. ***PBG shall be submitted separately for each State for Part-A and Part-B.***

The formula applicable to calculate the PBG amount will be:

$$\text{PBG amount for allocation in a State} = (\text{Rs. 15.00 Lakh}) \times \text{Allocated Capacity in MWp in a State} = \text{"A"}$$

Example: Allocating for 500kWp in State Rajasthan, the bidder has to submit PBG of Rs. 15.00 Lakh X 500/1000 MWp = Rs. 7.5 Lakh(Rupees Seven Lakhs Fifty Thousand Only).

3.16.2. The value of PBG indicated above is to be furnished by such Successful Bidder who has quoted a price which is not less than or equal to 85% of the maximum allowable cost @ Rs. 80/Wp.

However, in case of Successful Bidder, who has quoted a price which is less than 85% of the maximum allowable cost @ Rs. 80/Wp, then such Successful Bidder shall have to furnish enhanced PBG in the following manner:

Price quoted by the successful bidders as% of bench mark cost	Value of Performance BG
≥ 85%	100% of "A"
≥ 70% < 85%	150% of "A"
< 70%	200% of "A"

**For Example:** If the Successful Bidder quotes Rs. 60/Wp for a capacity of 1.5MWp then he needs to furnish the PBG amount as under:

$$\begin{aligned}\text{PBG amount} &= \text{Rs.15 lakhs} \times 1.5 \text{ MW} \times 150\% \\ &= \text{Rs } 15 \times 1.5 \text{ MW} \times 1.5 \\ &= \text{Rs. 22.5 lakhs}\end{aligned}$$

**Note: PBG calculation is applicable for the bid for Part-B as well as Part-A capacity as per their price bid.**

- 3.16.3. However, the Successful bidder other than L1 who matches the L1 price as per Clause 6.3.2.4 will submit the PBG amount at its Quoted project cost and not at L1 price.

**For example:** If the Successful bidders in case of Tamil Nadu has quoted

L1 price as Rs 53/Wp for 1.5 MW and L2 price as Rs 69/Wp for 1.5 MW and L2 agrees to match L1 price then L2 has to submit the PBG calculated as follows:

$$\begin{aligned}\text{PBG for L2 bidder} &= 100\% \times 1.5 \text{ MW} \times 15 \text{ Lakhs} \\ &= \text{Rs } 22.5 \text{ Lakhs}\end{aligned}$$

$$\begin{aligned}\text{PBG for L1 bidder} &= 200\% \times 1.5 \text{ MW} \times 15 \text{ lakhs} \\ &= \text{Rs } 45 \text{ Lakhs}\end{aligned}$$

- 3.16.4. The Performance Security shall be denominated in Indian Rupees and shall be in one of the following forms:

- a. a demand draft, or a bank guarantee from the List of banks as given in Annexure-B
- b. be confirmed for payment by the branch of the bank giving the bank guarantee at New Delhi.

- 3.16.5. The PBG shall be forfeited as follows without prejudice to the Bidder being liable for any further consequential loss or damage incurred to SECI.

- a. If the Successful Bidder is not able to identify the projects and submit Project Sanction Documents to the satisfaction of SECI, PBG amount, pro-rata to the capacity for which the Successful Bidder is not able to identify the Projects and submit Project Sanction Documents.
- b. If the Successful Bidder is not able to commission the projects to the satisfaction of SECI, PBG amount, pro-rata to the capacity not commissioned by the Successful Bidder. However, Hundred percent (100%) PBG amount furnished for the Sanctioned Capacity for the SECI identified locations, if the Successful Bidder fails to Commission the Projects(s) to the satisfaction of SECI.

**Note: SECI Identified locations are those which are notified by SECI in the RFS with firm capacity and location only or for which letter/email has been issued by SECI to the Successful bidder.**

- c. If the Successful Bidder fails to commission/identify the capacity allocated for Part-B consumers then 100% of the PBG amount shall be forfeited pro-rata to the capacity unidentified/ non-commissioned only.
  - d. In all the above cases corresponding unidentified/non-commissioned capacity shall stand cancelled.
- 3.16.6. The Performance Security shall be valid for a minimum period of 18 months from the date of issue of Allocation letter(s) and shall be renewed / extended till the completion of 5 years of O&M.

### **3.17. OPENING OF BIDS**

- 3.17.1. Envelope-I of the Bidders shall be opened at 1500 hours on Bid Deadline date at SECI office, in the presence of one representative from each of the Bidders who wish to be present.
- 3.17.2. Name of the Bidder, capacity offered for each State shall be read out to all the Bidders at the time of opening of Envelope-I and / or Envelope-II.

### **3.18. RIGHT TO WITHDRAW THE RFS AND TO REJECT ANY BID**

- 3.18.1. This RFS may be withdrawn or cancelled by the SECI at any time without assigning any reasons thereof. The SECI further reserves the right, at its complete discretion, to reject any or all of the Bids without assigning any reasons whatsoever and without incurring any liability on any account.
  - 3.18.1.1. The SECI reserve the right to interpret the Bid submitted by the Bidder in accordance with the provisions of the RFS and make its own judgment regarding the interpretation of the same. In this regard the SECI shall have no liability towards any Bidder and no Bidder shall have any recourse to the SECI with respect to the selection process. SECI shall evaluate the Bids using the evaluation process specified in Section -I, at its sole discretion. SECI decision in this regard shall be final and binding on the Bidders.
  - 3.18.1.2. SECI reserves its right to vary, modify, revise, amend or change any of the terms and conditions of the Bid before submission. The decision regarding acceptance or rejection of bid by SECI will be final.

### **3.19. ZERO DEVIATION**

- 3.19.1. This is a ZERO Deviation Bidding Process. Bidder is to ensure compliance of all provisions of the Bid Document and submit their Bid accordingly. Tenders with any deviation to the bid conditions shall be liable for rejection.

### **3.20. EXAMINATION OF BID DOCUMENT**

- 3.20.1. The Bidder is required to carefully examine the Technical Specification, terms and Conditions of Contract, and other details relating to supplies as given in the Bid Document.

- 3.20.2. The Bidder shall be deemed to have examined the bid document including the agreement/contract, to have obtained information on all matters whatsoever that might affect to execute the project activity and to have satisfied himself as to the adequacy of his bid. The bidder shall be deemed to have known the scope, nature and magnitude of the supplies and the requirements of material and labour involved etc. and as to all supplies he has to complete in accordance with the Bid document.
- 3.20.3. Bidder is advised to submit the bid on the basis of conditions stipulated in the Bid Document. Bidder's standard terms and conditions if any will not be considered. The cancellation / alteration / amendment / modification in Bid documents shall not be accepted by SECI.
- 3.20.4. Bid not submitted as per the instructions to bidders is liable to be rejected. Bid shall confirm in all respects with requirements and conditions referred in this bid document.

## **B. CONDITIONS OF CONTRACT**

### **3.21. SCOPE OF WORK**

- 3.21.1. The scope of work for the bidder include Identification of buildings/leasing rooftop of buildings for 25 years, Obtaining No Objection Certificate (NOC)" from Distribution Company (DISCOM) for grid connectivity, complete design, engineering, manufacture, supply, storage, civil work, erection, testing & commissioning of the grid connected rooftop solar PV project including operation and maintenance (O&M) of the project for a period of Five years after commissioning.

### **3.22. PROJECT COST**

- 3.22.1. The Project cost shall include all the costs related to above Scope of Work. Bidder shall quote for the entire facilities on a "single responsibility" basis such that the total Bid Price covers all the obligations mentioned in the Bidding Documents in respect of Design, Supply, Erection, Testing and Commissioning including Warranty, Operation & Maintenance for a period of 5 years, goods and services including spares required if any during O&M period. The Bidder has to take all permits, approvals and licenses, Insurance etc., provide training and such other items and services required to complete the scope of work mentioned above.
- 3.22.2. The project cost quoted is on lump sum turnkey basis and the bidder is responsible for the total Scope of Work described at Clause 3.21.1 above.
- 3.22.3. The project cost shall remain firm and fixed and shall be binding on the Successful Bidder till completion of work for payment of subsidy amount irrespective of his actual cost of execution of the project. No escalation will be granted on any reason whatsoever. The bidder shall not be entitled to

claim any additional charges, even though it may be necessary to extend the completion period for any reasons whatsoever.

3.22.4. The cost shall be inclusive of all duties and taxes, insurance etc .The prices quoted by the firm shall be complete in all respect and no price variation /adjustment shall be payable

3.22.5. The operation & maintenance of Solar Photovoltaic Power Plant would include wear, tear, overhauling, machine breakdown, insurance, and replacement of defective modules, invertors / Power Conditioning Unit (PCU), spares, consumables & other parts for a period of 5 years.

3.22.6. The **Project cost** shall be specified in sanction letter based on Successful Bidder's quote for each state. The project cost shall be in accordance with all terms, conditions, specifications and other conditions of the Contract as accepted by the SECI and incorporated into the sanction letter.

3.22.7. The Bidder shall complete the Price Bid (Format-B) for each State (Section-IV) furnished in the RFS Documents.

### 3.23. **SECI SERVICE CHARGES**

3.23.1. The successful bidders shall pay the following % (percentage) of the awarded Project Cost of the state as SECI service charges.

- a. Successful bidder(s) shall pay 5% of 85 % of L1 Project cost of the state as SECI service charges.
- b. SECI service charges shall be applicable based on the individual project size.

3.23.2. SECI service charges are for site visits, inspection; liaison, monitoring etc. Taxes and duties shall be paid extra. The SECI service charges are non-refundable and for each project the service charges has to be paid within 15 days from date of issuance of Sanction letter by SECI. Further, any delay beyond 15 days shall attract interest @ 1.25 % per month of the amount not paid, calculated on day to day basis till the full payment including interest is paid. SECI has the right to recover / adjust any unpaid SECI service charges including interest from the 1st instalment of subsidy due to the Successful Bidder. SECI at its sole discretion may cancel the Sanctioned capacity and forfeit 100% of Performance Security in case SECI service charges are not paid within 30 days of issue of Sanction Letter.

### 3.24. **INSURANCE**

3.24.1. The Bidder shall be responsible and take an Insurance Policy for transit-cum-storage-cum-erection for all the materials to cover all risks and liabilities for supply of materials on site basis, storage of materials at site, erection, testing



and commissioning. The bidder shall also take appropriate insurance during O&M period.

3.24.2. The Bidder shall also take insurance for Third Party Liability covering loss of human life, engineers and workmen and also covering the risks of damage to the third party/material/equipment/properties during execution of the Contract. Before commencement of the work, the Bidder will ensure that all its employees and representatives are covered by suitable insurance against any damage, loss, injury or death arising out of the execution of the work or in carrying out the Contract. Liquidation, Death, Bankruptcy etc., shall be the responsibility of bidder.

### 3.25. **WARRANTEES AND GUARANTEES**

3.25.1. The Bidder shall warrant that the goods supplied under this contract are new, unused, of the most recent or latest technology and incorporate all recent improvements in design and materials. The bidder shall provide system warrantee covering the rectification of any and all defects in the design of equipment, materials and workmanship including spare parts for a period of 5 years from the date of commissioning. The successful bidder has to transfer all the Guarantees /Warrantees of the different components to the Owner of the project. The responsibility of operation of Warrantee and Guarantee clauses and Claims/ Settlement of issues arising out of said clauses shall be joint responsibility of the Successful bidder and the owner of the project and SECI will not be responsible in any way for any claims whatsoever on account of the above.

### 3.26. **TYPE AND QUALITY OF MATERIALS AND WORKMANSHIP**

3.26.1. The design, engineering, manufacture, supply, installation, testing and performance of the equipment shall be in accordance with latest appropriate IEC/Indian Standards as detailed in the Section- III (Technical specifications) of the bid document. Where appropriate Indian Standards and Codes are not available, other suitable standards and codes as approved by the MNRE shall be used.

3.26.2. The specifications of the components should meet the technical specifications mentioned in Section III.

3.26.3. Any supplies which have not been specifically mentioned in this Contract but which are necessary for the design, engineering, manufacture, supply & performance or completeness of the project shall be provided by the Bidder without any extra cost and within the time schedule for efficient and smooth operation and maintenance of the SPV plant.

### 3.27. **OPERATION & MAINTENANCE (O&M)**

3.27.1. The bidder shall be responsible for operation and maintenance of the Roof top Solar PV system of capacity above 10kWp for a period of 5 years, during which SECI will monitor the project for effective performance in line with conditions specified elsewhere in the bid document and for project

having capacity upto 10kWp (Part-B consumers) project should have warranty for 5 years only. During this period, the bidder shall be responsible for supply of all spare parts as required from time to time for scheduled and preventive maintenance, major overhauling of the plant, replacement of defective modules, inverters, PCU's etc and maintaining log sheets for operation detail, deployment of staff for continuous operations and qualified engineer for supervision of O&M work, complaint logging & its attending.

**3.28. METERING AND GRID CONNECTIVITY**

Metering and grid connectivity of the roof top solar PV system under this scheme would be the responsibility of the Bidder in accordance with the prevailing guidelines of the concerned DISCOM and / or CEA (if available by the time of implementation). SECI/SNA could facilitate connectivity; however the entire responsibility lies with bidder only.

**3.29. PLANT PERFORMANCE EVALUATION**

The successful bidder shall be required to meet minimum guaranteed generation with Performance Ratio (PR) at the time of commissioning and related Capacity Utilization Factor (CUF) as per the GHI levels of the location during the O&M period. PR should be shown minimum of 75% at the time of inspection for initial commissioning acceptance to qualify for release of 10% subsidy and as per Clause 6.9 of Section-II. Minimum CUF of 15% should be maintained for a period of 5years. The bidder should send the periodic plant output details to SECI for ensuring the CUF. The PR will be measured at Inverter output level during peak radiation conditions.

**3.30. PROGRESS REPORT**

The bidder shall submit the progress report monthly to SECI in Prescribed Proforma. SECI will have the right to depute his/their representatives to ascertain the progress of contract at the premises of works of the bidder.

**3.31. PROJECT INSPECTION.**

The project above 10kWp progress will be monitored by SECI and the projects will be inspected for quality at any time during commissioning or after the completion of the project either by officer(s) from SECI or any authorized agency/ experts.

3.31.1. Project(s) below 10kWp shall be inspected by the bidder from the SECI list of empanelled experts as per the checklist requirement of SECI for release of subsidy, if required by SECI. All the expenses for inspection in this regard shall be borne by the Bidder only.

3.31.1.1. SECI reserves the right to do sample inspection checks for the projects commissioned by the Bidder.

3.31.2. SECI may also depute a technical person(s) from its list of empanelled experts for inspection, Third party verification, monitoring of system installed to oversee, the implementation as per required standards and also to visit the manufactures facilities to check the quality of products as well as to visit the system integrators to assess their technical capabilities as and when required.

**3.32. CANCELLATION OF SUBSIDY**

SECI will not release the subsidy for any shortcomings in commissioning as per technical specifications mentioned or for performance ratio (PR) below the specified limit (75%) after commissioning. Also the performance related subsidy will not be released in case CUF falls below 15% during O&M period of 5 years.

**3.33. APPLICABLE LAW**

The Contract shall be interpreted in accordance with the laws of the Union of India.

**3.34. SETTLEMENT OF DISPUTE**

3.34.1. If any dispute of any kind whatsoever arises between SECI and Successful bidder in connection with or arising out of the contract including without prejudice to the generality of the foregoing, any question regarding the existence, validity or termination, the parties shall seek to resolve any such dispute or difference by mutual consent. .

3.34.2. If the parties fail to resolve, such a dispute or difference by mutual consent, within 45 days of its arising, then the dispute shall be referred by either party by giving notice to the other party in writing of its intention to refer to arbitration as hereafter provided regarding matter under dispute. No arbitration proceedings will commence unless such notice is given. Any dispute in respect of which a notice of intention to commence arbitration has been given in accordance with Sub Clause 3.35.2, shall be finally settled by arbitration.

**3.34.3. IN CASE THE CONTRACTOR IS A PUBLIC SECTOR ENTERPRISE OR A GOVERNMENT DEPARTMENT.**

3.34.3.1. In case the Contractor is a Public Sector Enterprise or a Government Department, the dispute shall be referred for resolution in Permanent Machinery for Arbitration (PMA) of the Department of Public Enterprise, Government of India. Such dispute or difference shall be referred by either party for Arbitration to the sole Arbitrator in the Department of Public Enterprises to be nominated by the Secretary to the Government of India in-charge of the Department of Public Enterprises. The award of the Arbitrator shall be binding upon the parties to the dispute, provided, however, any party aggrieved by such award may make a further reference for setting aside or revision of the award to the Law Secretary, Department of Legal Affairs, Ministry of Law & Justice, Government of

India. Upon such reference the dispute shall be decided by the Law Secretary or the Special Secretary / Additional Secretary, when so authorized by the Law Secretary, whose decision shall bind the Parties finally and conclusive. The Parties to the dispute will share equally the cost of arbitration as intimated by the Arbitrator.

**3.34.4. IN CASE THE CONTRACTOR IS NOT A PUBLIC SECTOR ENTERPRISE OR A GOVERNMENT DEPARTMENT.**

3.34.4.1. In all other cases, any dispute submitted by a party to arbitration shall be heard by an arbitration panel composed of three arbitrators, in accordance with the provisions set forth below.

3.34.4.2. The SECI and the Contractor shall each appoint one arbitrator, and these two arbitrators shall jointly appoint a third arbitrator, who shall chair the arbitration panel. If the two arbitrators do not succeed in appointing a third arbitrator within Thirty (30) days after the latter of the two arbitrators has been appointed, the third arbitrator shall, at the request of either party, be appointed by the Appointing Authority for third arbitrator which shall be the President, Institution of Engineers.

3.34.4.3. If one party fails to appoint its arbitrator within thirty (30) days after the other party has named its arbitrator, the party which has named an arbitrator may request the Appointing Authority to appoint the second arbitrator.

3.34.4.4. If for any reason an arbitrator is unable to perform its function, the mandate of the Arbitrator shall terminate in accordance with the provisions of applicable laws as mentioned in Clause 3.34 (Applicable Law) and a substitute shall be appointed in the same manner as the original arbitrator.

3.34.4.5. Arbitration proceedings shall be conducted with The Arbitration and Conciliation Act, 1996. The venue or arbitration shall be New Delhi.

3.34.4.6. The decision of a majority of the arbitrators (or of the third arbitrator chairing the arbitration panel, if there is no such majority) shall be final and binding and shall be enforceable in any court of competent jurisdiction as decree of the court. The parties thereby waive any objections to or claims of immunity from such enforcement.

3.34.4.7. The arbitrator(s) shall give reasoned award.

3.34.5. Notwithstanding any reference to the arbitration herein, the parties shall continue to perform their respective obligations under the agreement unless they otherwise agree.

3.34.6. Cost of arbitration shall be equally shared between the Successful bidder or Contractor and SECI.

### **3.35. FORCE MAJEURE**

- 3.35.1. Notwithstanding the provisions of clauses contained in this RFS document; the contractor shall not be liable to forfeit (a) Security deposit for delay and (b) termination of contract; if he is unable to fulfill his obligation under this contract due to force majeure conditions.
- 3.35.2. For purpose of this clause, "Force Majeure" means an event beyond the control of the contractor and not involving the contractor's fault or negligence and not foreseeable, either in its sovereign or contractual capacity. Such events may include but are not restricted to Acts of God, wars or revolutions, fires, floods, epidemics, quarantine restrictions and fright embargoes etc. Whether a "Force majeure" situation exists or not, shall be decided by SECI and its decision shall be final and binding on the contractor and all other concerned.
- 3.35.3. In the event that the contractor is not able to perform his obligations under this contract on account of force majeure, he will be relieved of his obligations during the force majeure period. In the event that such force majeure extends beyond six months, SECI has the right to terminate the contract in which case, the security deposit shall be refunded to him.
- 3.35.4. If a force majeure situation arises, the contractor shall notify SECI in writing promptly, not later than 14 days from the date such situation arises. The contractor shall notify SECI not later than 3 days of cessation of force majeure conditions. After examining the cases, SECI shall decide and grant suitable additional time for the completion of the work, if required.

### **3.36. LANGUAGE**

- 3.36.1. All documents, drawings, instructions, design data, calculations, operation, maintenance and safety manuals, reports, labels and any other data shall be in English Language. The contract agreement and all correspondence between the SECI and the bidder shall be in English language.

### **3.37. OTHER CONDITIONS**

- 3.37.1. The Successful bidder shall not transfer, assign or sublet the work under this contract or any substantial part thereof to any other party without the prior consent of SECI in writing.
- 3.37.2. The Successful bidder shall not display the photographs of the work and not take advantage through publicity of the work without written permission of SECI and owner of the Rooftop.
- 3.37.3. The Successful bidder shall not make any other use of any of the documents or information of this contract, except for the purposes of performing the contract.
- 3.37.4. **SUCCESSORS AND ASSIGNS:**  
In case the SECI or Successful bidder may undergo any merger or amalgamation or a scheme of arrangement or similar re-organization & this

contract is assigned to any entity (ies) partly or wholly, the contract shall be binding mutatis mutandis upon the successor entities & shall continue to remain valid with respect to obligation of the successor entities.

**3.37.5. SEVERABILITY:**

It is stated that each paragraph, clause, sub-clause, schedule or annexure of this contract shall be deemed severable & in the event of the unenforceability of any paragraph, clause sub-clause, schedule or the remaining part of the paragraph, clause, sub-clause, schedule annexure & rest of the contract shall continue to be in full force & effect.

**3.37.6. COUNTERPARTS:**

This contract may be executed in one or more counterparts, each of which shall be deemed an original & all of which collectively shall be deemed one of the same instrument.

**3.37.7. RIGHTS & REMEDIES UNDER THE CONTRACT ONLY FOR THE PARTIES:**

This contract is not intended & shall not be construed to confer on any person other than the SECI & Successful bidder hereto, any rights and / or remedies herein.

**3.37.8. PRICE PREFERENCE FOR M.S.M.E/ STATE OR CENTRAL PSUS**

There is no relaxation in terms of any conditions of the RFS or price preference or processing fee or Bid Bond or PBG for M.S.M.E/ State or Central PSUs.

**3.37.9. CORRESPONDENCE**

Applicant/Bidder requiring any clarification on bid documents may contact in writing or by Fax /E Mail.

## **SECTION-II**

### **4. EVALUATION CRITERIA AND SUBSIDY DISBURSEMENT**

#### **(i) BID EVALUATION AND SUBSIDY DISBURSEMENT**

##### **i.1. BID EVALUATION**

The evaluation process comprises the following four steps:

Step I - Responsiveness check of Techno Commercial Bid

Step II -Evaluation of Bidder's fulfilment of Eligibility Criteria as per Clause 3.6 of Section-I

Step III -Evaluation of Price Bid

Step IV -Successful Bidders(s) selection

##### **i.2. RESPONSIVENESS CHECK OF TECHNO COMMERCIAL BID**

The Techno Commercial Bid submitted by Bidders shall be scrutinized to establish responsiveness to the requirements laid down in the RFS subject to Clause 3.6.1, Clause 3.6.2, and Clause 3.6.3. Any of the following may cause the Bid to be considered "Non-responsive", at the sole discretion of SECI:

- a. Bids that are incomplete, i.e. not accompanied by any of the applicable formats inter alia covering letter, power of attorney supported by a board resolution, applicable undertakings, format for disclosure, valid Bid Bond, etc.;
- b. Bid not signed by authorized signatory and /or stamped in the manner indicated in this RFS;
- c. Material inconsistencies in the information /documents submitted by the Bidder, affecting the Eligibility Criteria;
- d. Information not submitted in the formats specified in this RFS;
- e. Bid being conditional in nature;
- f. Bid not received by the Bid Deadline;
- g. Bid having Conflict of Interest;
- h. More than one Member of a Bidding Company using the credentials of the same Parent Company /Affiliate;
- i. Bidder delaying in submission of additional information or clarifications sought by SECI as applicable;
- j. Bidder makes any misrepresentation.

Each Bid shall be checked for compliance with the submission requirements set forth in this RFS before the evaluation of Bidder's fulfilment of Eligibility Criteria is taken up. Clause 3.6 shall be used to check whether each Bidder meets the stipulated requirement.

## **5. PRELIMINARY EXAMINATION**

5.1. The SECI will examine the Bids to determine whether they are complete, whether any computational errors have been made, whether required sureties have been furnished, whether the documents have been properly signed and stamped and whether the Bids are otherwise in order.

5.2. Arithmetical errors will be rectified on the following basis. If there is a discrepancy between the unit price and the total Amount that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total amount shall be corrected. If there is a discrepancy between words and figures, the amount written in words will prevail.

## **6. EVALUATION OF BIDDER'S FULFILMENT OF ELIGIBILITY CRITERIA**

6.1. Evaluation of Bidder's Eligibility will be carried out based on the information furnished by the Bidder as per the prescribed Formats and related documentary evidence in support of meeting the Eligibility Criteria as specified in Clause 3.6. Non-availability of information and related documentary evidence for the satisfaction of Eligibility Criteria may cause the Bid to be non-responsive.

### **6.2. EVALUATION OF PRICE BID**

Price Bid (Envelope III) of the Qualified Bidders shall be opened in presence of the representatives of such Qualified Bidders, who wish to be present, on a date as may be intimated by SECI to the Bidders through SECI website [www.seci.gov.in](http://www.seci.gov.in) or Email. The evaluation of Price Bid shall be carried out based on the information furnished in Envelope III (Price Bid). The Price Bid submitted by the Bidders shall be scrutinized to ensure conformity with the RFS. Any Bid not meeting any of the requirements of this RFS may cause the Bid to be considered "Non-responsive" at the sole decision of the SECI. The Price bids for the for each State shall be evaluated separately for CAPEX(Part-A and Part-B) as follows:

#### **CAPEX (Part-A and Part-B)**

6.2.1. The Price bids for the for each State shall be evaluated separately as follows;

- a. The Price bids for each State shall be evaluated separately on project cost basis quoted for Part-A capacity and Part-B capacity.



- b. Since the maximum allowable project cost is Rs 80/Wp, so bidder submitting bid above the maximum allowable project cost for Part-B and/or Part-A capacity as per the price bid shall be rejected.

### 6.3. **SUCCESSFUL BIDDER(S) SELECTION**

6.3.1. Bids qualifying in Clause 3.6 shall only be evaluated in this stage.

6.3.2. The Project Cost requirement for Part-A capacity as well as for Part-B capacity quoted in all Price Bids of Qualified Bidders shall be ranked from the lowest to the highest for each State separately.

6.3.2.1. Based on the price bid quoted by the bidders for Part-A capacity, SECI shall arrange the bids in the ascending order i.e. L1, L2, L3, \_ \_ \_ (L1 being the lowest project cost for Part-A capacity). Similar process as per clause 6.3.2.1 will be adopted for Part-B capacity separately.

6.3.2.2. For all the states and for Part-B and Part-A capacity, lowest bidder will be declared as the successful bidder. For further allocation, the L2 bidder will be asked to match the price quoted by the L1 bidder. In case the L2 bidder refuses to match the L1 price then L3 bidder shall be offered to match L1 price. The process will continue till the next bidder matches the L1 price. The bidder who matches the L1 price will also be declared Successful bidder for that state. The intent is to have two bidders in a State for Part-A and Part-B capacity .However, SECI at its own discretion may relax the condition.

6.3.2.3. Similar process as per clause 6.3.2 will be adopted for all the States separately.

6.3.2.4. All the qualified bidders of a State and empanelled companies of the State except the L1 bidder will be given 10 days from the date of notification of L1 price on SECI website to give their consent to execute the work at L1 price failing which it will be assumed that they are not interested to match L1 price. In case of more than one such response is received expressing their consent to match the L1 price and to execute the capacity in the State then the preference shall be given in the ascending order of the bid quoted by the bidder. ie first

preference will be given to L2 then L3 and so on until entire capacity is allocated.

6.3.2.5. If none of the qualified bidder matches the L1 price in a State then preference shall be given to other empanelled company of the State in the alphabetical order of their names.

6.3.2.6. Empanelled companies shall give their consent with bid bond of the equivalent amount so as to make them eligible for capacity allocation.

- 6.3.3. Letter(s) of Allocation (LOA): The Letter(s) of Allocation (LOA) shall be issued to all such Successful Bidders(s) selected as per the provisions of this Clause 6.3.2
- 6.3.4. Each Successful Bidder shall acknowledge the LOA and return duplicate copy with signature & stamp of the authorized signatory of the Successful Bidder to the SECI within Thirty (30) days of issue of LOA.
- 6.3.5. If the Successful Bidder, to whom the Letter of Allocation has been issued does not fulfil any of the conditions specified in Bid document, the SECI reserves the right to annul/cancel the award of the Letter of Allocation of such Successful Bidder and forfeit the PBG/Bid Bond.
- 6.3.6. The SECI at its own discretion, has the right to reject any or all the Bids without assigning any reason whatsoever, at its sole discretion
- 6.3.7. There shall be no negotiation on the quoted Project cost or Subsidy requirement between the SECI and the Bidder(s), during the process of evaluation.
- 6.3.8. **For Part-A and Part-B**

The intent has been to have more than one bidder in a State at L1 rate .So apart from the procedure adopted under clause 6.3.2 of RFS, following methodology shall be adopted to allocate the remaining capacity, ***if none of the qualified bidder and empanelled company of the State matches the L1 price in a State:***

- 6.3.8.1. In such cases, the details of the remaining capacity under each State and the L1 price of that State will be notified through SECI website for information to all the empanelled companies on pan-India basis. All empanelled companies on pan-India basis within 10 days from the date of notification on SECI website or against individual intimation shall give their consent along with the Bid bond of equivalent amount to SECI for execution of the remaining capacity at L1 rate of the State they are interested.
- 6.3.8.2. In case of more than one such response is received expressing their consent to execute the capacity in the State they are interested then the preference shall be given in the alphabetical order of their names.

#### 6.4. **INCREASE/DECREASE OF BIDDER ALLOCATED CAPACITY IN A STATE**

- 6.4.1. SECI reserves the right to increase upto twenty five percent (25%) of the Bidder Allocated Capacity at its sole discretion and at the request of the Bidder at L1 price of the State only.

6.4.2. In case bidder has requested for reduction in Allocated capacity, then upto 25% reduction of allocated capacity in a State for Part-A capacity only can be accepted by SECI without forfeiture of PBG at SECI sole discretion subject to the condition that bidder has received atleast sanction of 75% of allocated capacity for Part-A capacity for that state.

6.4.3. In case capacity is modified by SECI as per Clause 6.4.1 & 6.4.2 above, Successful bidder shall submit the equivalent amount of PBG/Amended PBG to SECI within 30 days from the date of issue of allocation letter /sanction letter.

## 6.5. **TRANSFER OF CAPACITY**

6.5.1. At sole discretion of SECI, SECI may allow transfer of allocated capacity in full or part. However, such transfer shall generally be allowed as per Bidder request, if agreed by SECI.

6.5.2. Part-B capacity shall be non-transferrable. However, competent authority of SECI at its own discretion can relax the condition.

6.5.3. Inter-state transfer of allocated capacity as per the request may be allowed, subject to above clause 6.5.1 at the price quoted by Successful bidder of the transferor State or at the L1 price of the new State, whichever is lower. Transfer of capacity as per Clause 6.5.1 and Clause 6.5.2 shall be done within the states indicated in table of Clause 2.1.3.

**For example-1:** If the capacity is transferred from State AP where L1 price is Rs 70/Wp to the State Tamil Nadu where L1 price is Rs 75 then transferred capacity of the bidder shall be permitted at the Rs 70/Wp only.

**For example-2:** If the capacity is transferred from State AP where L1 price is Rs 70/Wp to the State Tamilnadu where L1 price is Rs. 65/Wp then transferred capacity of the bidder shall be permitted at the Rs 65/Wp only.

6.5.4. Amended Performance security (PBG pertaining to additional capacity allocated or capacity transferred shall be submitted by bidder within 30 days from the date of issue of such notification.

**Note:** Increase/decrease/transfer of the Successful Bidder Capacity at the time of Allocation will be at the sole discretion of SECI.

## 6.6. **NOTIFICATION TO SUCCESSFUL BIDDERS**

6.6.1. The name of Successful Bidders shall be notified indicating the allocated capacity and the awarded project price in a state on SECI website [www.seci.gov.in](http://www.seci.gov.in) and also shall be notified individually through letter of allocation.

## **6.7. MAXIMUM CHARGEABLE TARIFF FOR ENERGY SALE**

Energy sale will be allowed and the maximum chargeable levelled tariff (per year) is up to Rs. 6.00/kWh for 25 years.

## **6.8. PROJECT ALLOCATION AND SANCTION**

6.8.1. The identification of the projects (roof tops) at time of bidding is not mandatory. The Bidders, however, in their own interest are advised to make a preliminary survey of availability of roof tops in the cities of the States for which they intend to Bid, as well as issue of Grid connectivity, as non-availability of roof tops and non-completion of other formalities after allocation of project will result in forfeiture of Bid Bond/PBG amount submitted by them.

6.8.2. The Successful Bidders selected as described in Clause 6.3 above shall be issued Letter of Allocation (LOA) indicating the allocated capacity for Part-B and Part-A & Project Cost for Part-B and Part-A etc.

6.8.3. The bidders who have been notified as Successful Bidders, shall be given 3 months from the date of issue of Letter of Allocation for identification of roof top.

6.8.3.1. Preference should be given to SECI identified roofs first. In the event of offer given by SECI to the Bidder to execute the project in the SECI identified roof, the time for submission of project sanction documents by the bidder to SECI will be 30 days from the date of issue of allocation letter which can be extended depending upon the merit of the case. Failure of non-compliance of same shall lead to forfeiture of PBG for that State in proportion to the capacity allocated in the SECI identified location.

6.8.3.2. Further, Successful Bidders can start submitting their Project sanction documents as soon as they receive LOA from SECI. Project sanction documents shall be submitted to SECI with minimum Project size of 10 kWp for Part-A consumers and less than 10 kW for Part-B consumers with maximum up to their allocated capacity. If after 3 months, the successful bidder could not identify rooftop(s) capacity up to the allocated capacity and submit Project sanction documents, in such case PBG for unidentified allocated capacity may be forfeited and the unidentified allocated capacity gets cancelled and bidder including its affiliates/GROUP COMPANIES/ Parent / Ultimate parent company may be debarred to participate in SECI's future tenders for a period as decided by the competent authority of SECI.

6.8.3.3. Successful bidders shall share the time and date stamping photographs of the roofs and location details with SECI before entering into any legal agreement with the Owner. This has to ensure that the location identified

by the Successful bidder is freshly identified and strictly complying the norms provided in Clause 13.2 below.

- 6.8.4. For identification of projects, SECI or state nodal agency (SNA) may provide help. However the entire responsibility of finding the buildings lies with the Bidder.
- 6.8.5. Onus of identifying the buildings/rooftops and completing the other documentation like finalizing the Project report and entering into agreements with the buildings/rooftops owners lies with the Successful Bidder within the above mentioned time frame even for the buildings/rooftops identified by SECI for preferential installation.
- 6.8.6. After the Project Sanctioned Document have been submitted by the Successful Bidder/ Project Developer and accepted by SECI", SECI will issue the Sanction Letter(s) for the Project (s) indicating the subsidy amount(s) which will be disbursed in line with the provisions of the RFS document. The Bidder shall complete the design, engineering, manufacture, supply, storage, civil work, erection, testing & commissioning of each project within 9 months from the date of issue of allocation Letter.
- 6.8.7. If the Bidder fails to commission the project within specified time, penalty on per day basis calculated for the Performance Security on a 6 month's period would be levied. After 6 months, the project will get cancelled and the total PBG would be forfeited. Please refer Clause 8& 9 below for details.

#### **6.9. SUBSIDY DISBURSEMENT:**

- 6.9.1. SECI will provide 15% of the L1 Project Cost awarded to the Successful Bidder in Price Bid for that state as subsidy.
- 6.9.2. The Project cost awarded to the bidder through letter of allocation shall be considered as the Project Cost for this purpose. Total liability of SECI under this contract shall be limited to release of this 15% subsidy on the L1 Project awarded to the Bidder through letter of allocation.
- 6.9.3. The subsidy of Part-A projects above 10kWp will be disbursed as follows.
  - a) Subsidy equivalent to 10% of the L1 Project Cost will be released after the issuance of Commissioning/ completion certificate and acceptance of project as per Clause 12.1.1
  - b) Subsidy equivalent to 2.5% of the L1 Project Cost will be released at the end of 1 year of O&M period from date of commissioning.
  - c) Remaining subsidy equivalent to 2.5% of the L1 Project Cost will be released at the end of 2 years of O&M period from date of commissioning.

6.9.4. The subsidy of Part-B projects below 10kWp will be disbursed as follows.

- a. Subsidy equivalent to 15% of the L1 Project Cost will be released after issuance of Commissioning and acceptance of project.

If any extra facilities are agreed between the Successful Bidder and the owner beyond the scope of this allocation letter/ RFS document than extra payment shall be made by the Owner on mutually decided (Owner & Successful Bidder) terms and conditions. In any case, SECI shall neither interfere in their business affairs nor shall be liable for extra claim by Successful Bidder or Owner.

6.9.5. SECI may consider to release as case to case basis depending on the actions taken by the Successful Bidder and the progress achieved in the process, the subsidy amount indicated at Clause 6.9.3 (a) above in case Grid connectivity of the Project has not been done although the Project is otherwise ready for the commissioning. However, the last 5% of subsidy as indicated in Clause 6.9.3 (b) and Clause 6.9.3 (c) above shall not be released till the project is connected with the Grid. No "NOC" from DISCOM is required for the grid connectivity for the Part-B projects (below 10kWp). However, this does not exempt the project requirement for grid connectivity. For avoidance of doubts on grid connectivity respective SERC and DISCOM norms must be followed.

6.9.6. In case the Successful Bidder/ Project Developer is not the Owner of the Project, subsidy shall be released to Successful Bidder/ Project Developer after written consent of Owner only.

## **7. OTHER CONDITIONS**

7.1. Bidder or owner of the building has to obtain all the necessary approvals/Consents/Clearances required for Erection, Testing, Commissioning and O&M of the project including Grid connectivity. SECI shall not have any responsibility in this regard.

7.2. Bid bond and Processing fee submission:

Bid bond shall be submitted separately for each State for the offered capacity in a separate envelop (along with Processing fee) superscripted with name of State for which Bid is being quoted & other details .However, Processing fee for all the States for which the bid and or application for empanelment is/are being submitted may be consolidated and a single DD may be furnished.

7.3. **TAX EXEMPTIONS:**

Price bids are invited inclusive of Taxes and duties. However, Tax exemptions including certificates of any sort, if available may be dealt with

the concerned Dep't of Govt. of India by the bidder. SECI in no case will be responsible for providing any tax exemptions to the bidder.

#### 7.4. **ELIGIBILITY OF STANDALONE SYSTEM:**

7.4.1. Standalone system is not allowed under this scheme. The system should be grid connected.

#### 7.5. **REQUIREMENT OF APPROVALS ON MAKES OF THE COMPONENTS:**

7.5.1. The modules should be manufactured in India only. Rest of the components can be procured from any source. However these items should meet the Technical specification and standards mentioned in RFS.

#### 7.6. **OPERATION OF THE SYSTEM DURING WEEKENDS AND GENERAL HOLIDAYS AND CALCULATION OF CUF:**

7.6.1. During grid failure, the SPV system stops generating. Any instances of grid failure need to be mentioned in the monthly report and those instances need to be authorised by local DISCOM. Then the period will be excluded in calculation of CUF.

7.7. Taxes and duties shall be paid extra by the bidder as applicable on the SECI service charges and the bid processing fee.

### 8. **PENALTY FOR DELAY IN PROJECT IMPLEMENTATION**

8.1. SECI will issue the sanction letter(s) for the Project (s) indicating the subsidy amount(s) which will be disbursed in line with the provisions of the RFS document. The Bidder shall complete the project identification, design, engineering, manufacture, supply, storage, civil work, erection, testing & commissioning of each project within 9 months from the date of issue of allocation letter.

8.2. If the bidder fails to commission the allocated capacity within 9 months from date of issue of allocation letter, Penalty on per day basis calculated for the Performance Security on a 6 months period would be levied. After 6 months allocated capacity will get cancelled and the PBG amount pro-rata to non-commissioned capacity would be forfeited.

**Example:** If a project of 500 kW is delayed by 36 days then the LD will be levied as given below.

PENALTY = ((Performance Security)/180 days)\*delayed days = (7, 50,000 /180)\*36

= Rs.1,50, 000.

### 9. **TIME OF COMPLETION OF ALLOCATED CAPACITY:**

9.1 Project completion shall be **9 months from the date of issue of allocation letter**. However, project identification time is limited upto 3 months from the date of issue of allocation letter within which bidder has to submit project

sanction documents to the satisfaction of SECI. Failure of non-compliance of same shall lead to forfeiture of PBG for that State in proportion to the capacity not identified.

**For example:** if “A” has submitted the project sanction documents within 6 months’ time to the satisfaction of SECI and in exceptional circumstances it has been considered by SECI and sanction letter has been issued in the 7<sup>th</sup> month then total time left for project commissioning shall be 3 months only.

- 9.2 For any additional capacity, bidder shall complete/commission the capacity within 3 months from the date of issue of allocation letter/sanction letter. This will include submission of project sanction documents to the satisfaction of SECI.
- 9.3 The period of construction given in Time Schedule includes the time required for mobilisation as well as testing, rectifications if any, retesting and completion in all respects to the entire satisfaction of the Engineer-in-Charge.
- 9.4 A joint programme of execution of the Work will be prepared by the Engineer-in-Charge or its representative nominated for the purpose and Successful bidders based on priority requirement of this project. This programme will take into account the time of completion mentioned in clause 9.1 above and the time allowed for the priority Works by the Engineer-in-Charge.
- 9.5 Monthly/Weekly implementation programme will; be drawn up by the Engineer-in-Charge jointly with the Successful bidder, based on availability of Work fronts as per Clause 9.4 above. Successful bidder shall scrupulously adhere to these targets /programmes by deploying adequate personnel, tools and tackles and he shall also supply himself all materials of his scope of supply in good time to achieve the targets/programmes. In all matters concerning the extent of targets set out in the weekly and monthly programmes and the degree of achievements, the decision of the Engineer-in-Charge will be final and binding.
10. **USER ID FOR UPDATING THE PROJECT PROGRESS ON BI-WEEKLY BASIS**
- Successful bidder authorised representative in whose name PoA has been executed and submitted along with the bid shall be provided Password and User id for updating the project progress on **monthly** basis in the sanction letter/Allocation letter for the State. Successful bidder should update the info as per the requirement of the software tool .Non updating of the progress shall be considered as no progress and shall attract punitive actions as per the relevant provision of the Contract. However, the decision of Engineer –in –charge shall be final in this regard.



## **11. INSPECTION AND AUDIT BY THE GOVERNMENT**

11.1. The Successful bidder shall permit the SECI to inspect the Successful bidder's site, accounts and records relating to the performance of the Contractor and to have them audited by auditors appointed by the SECI, if so required by the SECI any time.

## **12. COMMISSIONING /COMPLETION CERTIFICATE:**

12.1. Application for completion/commissioning certificate:

When the Successful bidder fulfils his obligation under the Contract, he shall be eligible to apply for Completion Certificate. The Engineer-in-Charge shall normally issue to the Successful bidder the Completion Certificate within one month after receiving any application therefore from the Successful bidder after verifying from the completion documents and satisfying himself that the Work has been completed in accordance with and as set out in Contract documents. The Successful bidder, after obtaining the Completion Certificate, is eligible to avail the subsidy as per the Clause 6.9

### **12.1.1. DOCUMENT SUBMISSION FOR ISSUE COMMISSIONING/ COMPLETION CERTIFICATE :**

For the purpose of Clause 12.1 above the following documents will be deemed to form the completion documents:

- a. Checklist for inspection of Roof top SPV power plants as per SECI format.
- b. Project completion report from successful bidder as per SECI format
- c. Project completion/satisfaction certificate from roof top owners/project developers.

### **12.1.2. FINAL DECISION AND FINAL CERTIFICATE:**

12.1.2.1. Upon completion of 5 years of O&M and subject to the Engineer-in-Charge being satisfied, the Engineer-in-Charge shall (without prejudice to the rights of the SECI to retain the provisions of relevant Clause hereof) otherwise give a certificate herein referred to as the Final Certificate to that effect and the Successful bidder shall not be considered to have fulfilled the whole of his obligations under Contract until Final Certificate shall have been given by the Engineer-in-Charge notwithstanding any previous entry upon the Work and taking possession, working or using of the same or any part thereof by the Owner of Roof/SECI.

## **12.2. DEDUCTIONS FROM THE CONTRACT PRICE:**

12.2.1. All costs, damages or expenses which SECI may have paid or incurred, which under the provisions of the Contract, the Successful bidder is liable/will be liable, will be claimed by the SECI. All such claims shall be billed by the SECI to the Contractor within 15 (fifteen) days of the receipt of the payment request and if not paid by the Successful bidder within the said period, the SECI may, then, deduct the amount from any moneys due i.e., Performance Security or becoming due to the contractor or Successful bidder under the contract or may be recovered by actions of law or otherwise, if the Successful bidder fails to satisfy the SECI of such claims.

### **12.3. CORRUPT OR FRAUDULENT PRACTICES**

The SECI requires that Successful Bidders/ Contractors should follow the highest standard of ethics during the execution of contract. In pursuance of this policy, the SECI:

- 12.3.1. defines, for the purposes of this provision, the terms set forth as follows :
- 12.3.2. "corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the bid process or in contract execution; and
- 12.3.3. "fraudulent practice" means a misrepresentation of facts in order to influence a bid process or the execution of a contract to the detriment of the SECI/Govt scheme, and includes collusive practice among Bidders (prior to or after Bid submission) designed to establish Bid prices at artificial non-competitive levels and to deprive the SECI of the benefits of free and open competition;
- 12.3.4. will declare a firm ineligible/debarred, either indefinitely or for a specific period of time, a GOVT contract if at any time it is found that the firm has engaged in corrupt or fraudulent practices in competing for, or in executing, a Government/ SECI schemes.

### **13. DEBARRED FROM PARTICIPATING IN SECI'S ROOF TOP TENDER**

- 13.1. SECI reserves the right to carry out the performance review of each Bidder from the time of submission of Bid onwards. In case it is observed that a bidder has not fulfilled its obligations in meeting the various timelines envisaged, in addition to the other provisions of the RFS, such Bidders may be debarred from participating in SECI's any future tender for a period as decided by the competent authority of SECI.
- 13.2. The Successful bidder must ensure that the ROOF TOP SOLAR PV SCHEME-PHASE-IV-Part-2 subsidy is available for newly commissioned projects i.e. for the projects whose construction/despatch of equipment's have been started only after the issue of sanction letter/allocation letter .Any roofs on which projects has been installed or commissioned before the issue of allocation letter/sanction letter shall be construed as fraudulent activity in

which case Successful bidder(s) may be debarred from participating in SECI's future tender for a period as decided by the Competent authority. However, such locations may be used for installation of additional capacity with the prior approval of competent authority.

## SECTION-III TECHNICAL SPECIFICATIONS

The proposed projects shall be commissioned as per the technical specifications given below. Any shortcomings will lead to cancelation of subsidy in full or part as decided by SECI & Competent Authority's decision will be final and binding on the bidder.

### 14. DEFINITION

A Grid Tied Solar Rooftop Photo Voltaic (SPV) power plant consists of SPV array, Module Mounting Structure, Power Conditioning Unit (PCU) consisting of Maximum Power Point Tracker (MPPT), Inverter, and Controls & Protections, interconnect cables and switches. PV Array is mounted on a suitable structure. Grid tied SPV system is without battery and should be designed with necessary features to supplement the grid power during day time. Components and parts used in the SPV power plants including the PV modules, metallic structures, cables, junction box, switches, PCUs etc., should conform to the BIS or IEC or international specifications, wherever such specifications are available and applicable.

Solar PV system shall consist of following equipments/components.

- Solar PV modules consisting of required number of **Crystalline** PV modules.
- Grid interactive Power Conditioning Unit with Remote Monitoring System
- Mounting structures
- Junction Boxes.
- Earthing and lightening protections.
- IR/UV protected PVC Cables, pipes and accessories

#### 14.1. SOLAR PHOTOVOLTAIC MODULES:

14.1.1. The PV modules used should be made in India.

14.1.2. The PV modules used must qualify to the latest edition of IEC PV module qualification test or equivalent BIS standards Crystalline Silicon Solar Cell Modules IEC 61215/IS14286. In addition, the modules must conform to IEC 61730 Part-2- requirements for construction & Part 2 – requirements for testing, for safety qualification or equivalent IS.

- a) For the PV modules to be used in a highly corrosive atmosphere throughout their lifetime, they must qualify to IEC 61701/IS 61701
- b) The total solar PV array capacity should not be less than allocated capacity (kWp) and should comprise of solar crystalline modules of minimum **250** Wp and above wattage. Module capacity less than minimum **250** watts should not be accepted
- c) Protective devices against surges at the PV module shall be provided. Low voltage drop bypass diodes shall be provided.

- d) PV modules must be tested and approved by one of the IEC authorized test centers.
- e) The module frame shall be made of corrosion resistant materials, preferably having anodized aluminum.
- f) The bidder shall carefully design & accommodate requisite numbers of the modules to achieve the rated power in his bid. SECI/owners shall allow only minor changes at the time of execution.
- g) Other general requirement for the PV modules and subsystems shall be the Following:
  - I. The rated output power of any supplied module shall have tolerance of +/- 3%.
  - II. The peak-power point voltage and the peak-power point current of any supplied module and/or any module string (series connected modules) shall not vary by more than 2 (two) per cent from the respective arithmetic means for all modules and/or for all module strings, as the case may be.
  - III. The module shall be provided with a junction box with either provision of external screw terminal connection or sealed type and with arrangement for provision of by-pass diode. The box shall have hinged, weather proof lid with captive screws and cable gland entry points or may be of sealed type and IP-65 rated.
  - IV. IV curves at STC should be provided by bidder.

14.1.3. Modules deployed must use a RF identification tag. The following information must be mentioned in the RFID used on each modules (This can be inside or outside the laminate, but must be able to withstand harsh environmental conditions).

- a) Name of the manufacturer of the PV module
- b) Name of the manufacturer of Solar Cells.
- c) Month & year of the manufacture (separate for solar cells and modules)
- d) Country of origin (separately for solar cells and module)
- e) I-V curve for the module Wattage,  $I_m$ ,  $V_m$  and FF for the module
- f) Unique Serial No and Model No of the module
- g) Date and year of obtaining IEC PV module qualification certificate.
- h) Name of the test lab issuing IEC certificate.
- i) Other relevant information on traceability of solar cells and module as per ISO 9001 and ISO 14001

**14.1.4. Warranties:**

- a) Material Warranty:
  - i. Material Warranty is defined as: The manufacturer should warrant the Solar Module(s) to be free from the defects and/or failures specified below for a period not less than five (05) years from the date of sale to the original customer ("Customer")
  - ii. Defects and/or failures due to manufacturing
  - iii. Defects and/or failures due to quality of materials

- iv. Non conformity to specifications due to faulty manufacturing and/or inspection processes. If the solar Module(s) fails to conform to this warranty, the manufacturer will repair or replace the solar module(s), at the Owners sole option
  - b) Performance Warranty:
    - i. The predicted electrical degradation of power generated not exceeding 20% of the minimum rated power over the 25 year period and not more than 10% after ten years period of the full rated original output.

#### 15. **ARRAY STRUCTURE**

- a) Hot dip galvanized MS mounting structures may be used for mounting the modules/ panels/arrays. Each structure should have angle of inclination as per the site conditions to take maximum insolation. However to accommodate more capacity the angle inclination may be reduced until the plant meets the specified performance ratio requirements.
- b) The Mounting structure shall be so designed to withstand the speed for the wind zone of the location where a PV system is proposed to be installed (like Delhi-wind speed of 150 km/ hour). It may be ensured that the design has been certified by a recognized Lab/ Institution in this regard and submit wind loading calculation sheet to SECI. Suitable fastening arrangement such as grouting and calming should be provided to secure the installation against the specific wind speed.
- c) The mounting structure steel shall be as per latest IS 2062: 1992 and galvanization of the mounting structure shall be in compliance of latest IS 4759.
- d) Structural material shall be corrosion resistant and electrolytically compatible with the materials used in the module frame, its fasteners, nuts and bolts. **Aluminium structures also can be used which can withstand the wind speed of respective wind zone.** Necessary protection towards rusting need to be provided either by coating or anodization.
- e) The fasteners used should be made up of stainless steel. The structures shall be designed to allow easy replacement of any module. The array structure shall be so designed that it will occupy minimum space without sacrificing the output from the SPV panels
- f) Regarding civil structures the bidder need to take care of the load bearing capacity of the roof and need arrange suitable structures based on the quality of roof.
- g) The total load of the structure (when installed with PV modules) on the terrace should be less than 60 kg/m<sup>2</sup>.
- h) The minimum clearance of the structure from the roof level should be 300 mm.

#### 16. **JUNCTION BOXES (JBs)**

- a) The junction boxes are to be provided in the PV array for termination of connecting cables. The J. Boxes (JBs) shall be made of GRP/FRP/Powder

Coated Aluminium /cast aluminium alloy with full dust, water & vermin proof arrangement. All wires/cables must be terminated through cable lugs. The JB's shall be such that input & output termination can be made through suitable cable glands.

- b) Copper bus bars/terminal blocks housed in the junction box with suitable termination threads conforming to IP65 standard and IEC 62208 Hinged door with EPDM rubber gasket to prevent water entry. Single / double compression cable glands. Provision of earthings. It should be placed at 5 feet height or above for ease of accessibility.
- c) Each Junction Box shall have High quality Suitable capacity Metal Oxide Varistors (MOVs) / SPDs, suitable Reverse Blocking Diodes. The Junction Boxes shall have suitable arrangement monitoring and disconnection for each of the groups.
- d) Suitable markings shall be provided on the bus bar for easy identification and the cable ferrules must be fitted at the cable termination points for identification

**17. DC DISTRIBUTION BOARD:**

- a) DC Distribution panel to receive the DC output from the array field.
- b) DC DPBs shall have sheet from enclosure of dust & vermin proof conform to IP 65 protection. The bus bars are made of copper of desired size. Suitable capacity MCBs/MCCB shall be provided for controlling the DC power output to the PCU along with necessary surge arrestors.

**18. AC DISTRIBUTION PANEL BOARD:**

- a) AC Distribution Panel Board (DPB) shall control the AC power from PCU/ inverter, and should have necessary surge arrestors. Interconnection from ACDB to mains at LT Bus bar while in grid tied mode.
- b) All switches and the circuit breakers, connectors should conform to IEC 60947, part I, II and III/ IS60947 part I, II and III.
- c) The changeover switches, cabling work should be undertaken by the bidder as part of the project.
- d) All the Panel's shall be metal clad, totally enclosed, rigid, floor mounted, air - insulated, cubical type suitable for operation on three phase / single phase, 415 or 230 volts, 50 Hz
- e) The panels shall be designed for minimum expected ambient temperature of 45 degree Celsius, 80 percent humidity and dusty weather.
- f) All indoor panels will have protection of IP54 or better. All outdoor panels will have protection of IP65 or better.
- g) Should conform to Indian Electricity Act and rules (till last amendment).
- h) All the 415 AC or 230 volts devices / equipment like bus support insulators, circuit breakers, SPDs, VTs etc., mounted inside the switchgear shall be suitable for continuous operation and satisfactory performance under the following supply conditions

Variation in supply voltage	+/- 10 %
Variation in supply frequency	+/- 3 Hz

**19. PCU/ARRAY SIZE RATIO:**

- a) The combined wattage of all inverters should not be less than rated capacity of power plant under STC.
- b) Maximum power point tracker shall be integrated in the PCU/inverter to maximize energy drawn from the array.

**20. PCU/ Inverter:**

As SPV array produce direct current electricity, it is necessary to convert this direct current into alternating current and adjust the voltage levels to match the grid voltage. Conversion shall be achieved using an electronic Inverter and the associated control and protection devices. All these components of the system are termed the “Power Conditioning Unit (PCU)”. In addition, the PCU shall also house MPPT (Maximum Power Point Tracker), an interface between Solar PV array & the Inverter, to the power conditioning unit/inverter should also be DG set interactive. If necessary. Inverter output should be compatible with the grid frequency. Typical technical features of the inverter shall be as follows:

- Switching devices : IGBT/MOSFET
- Control : Microprocessor /DSP
- Nominal AC output voltage and frequency : 415V, 3 Phase, 50 Hz (In case single phase inverters are offered, suitable arrangement for balancing the phases must be made.)
- Output frequency : 50 Hz
- Grid Frequency Synchronization range : + 3 Hz or more
- Ambient temperature considered : -20° C to 50° C
- Humidity : 95 % Non-condensing
- Protection of Enclosure : IP-20(Minimum) for indoor.  
: IP-65(Minimum) for outdoor.
- Grid Frequency Tolerance range : + 3 or more
- Grid Voltage tolerance : - 20% & + 15 %
- No-load losses : Less than 1% of rated power
- Inverter efficiency(minimum) : >93% ( In case of 10kW or above )
- Inverter efficiency (minimum ) : > 90% (In case of less than 10 kW)
- THD : < 3%



- PF

: > 0.9

- a) Three phase PCU/ inverter shall be used with each power plant system (10kW and/or above) but In case of less than 10kW single phase inverter can be used.
- b) PCU/inverter shall be capable of complete automatic operation including wake-up, synchronization & shutdown.
- c) The output of power factor of PCU inverter is suitable for all voltage ranges or sink of reactive power, inverter should have internal protection arrangement against any sustainable fault in feeder line and against the lightning on feeder.
- d) Built-in meter and data logger to monitor plant performance through external computer shall be provided.
- e) The power conditioning units / inverters should comply with applicable IEC/ equivalent BIS standard for efficiency measurements and environmental tests as per standard codes IEC 61683/IS 61683 and IEC 60068-2(1,2,14,30) /Equivalent BIS Std.
- f) The charge controller (if any) / MPPT units environmental testing should qualify IEC 60068-2(1, 2, 14, 30)/Equivalent BIS std. The junction boxes/ enclosures should be IP 65(for outdoor)/ IP 54 (indoor) and as per IEC 529 specifications.
- g) The PCU/ inverters should be tested from the MNRE approved test centres / NABL /BIS /IEC accredited testing- calibration laboratories. In case of imported power conditioning units, these should be approved by international test houses.

## 21. **INTEGRATION OF PV POWER WITH GRID:**

The output power from SPV would be fed to the inverters which converts DC produced by SPV array to AC and feeds it into the main electricity grid after synchronization. In case of grid failure, or low or high voltage, solar PV system shall be out of synchronization and shall be disconnected from the grid. Once the DG set comes into service PV system shall again be synchronized with DG supply and load requirement would be met to the extent of availability of power. 4 pole isolation of inverter output with respect to the grid/ DG power connection need to be provided.

## 22. **DATA ACQUISITION SYSTEM / PLANT MONITORING**

- i. Data Acquisition System shall be provided for each of the solar PV plant.
- ii. Data Logging Provision for plant control and monitoring, time and date stamped system data logs for analysis with the high quality, suitable PC. Metering and Instrumentation for display of systems parameters and status indication to be provided.

- iii. Solar Irradiance: An integrating Pyranometer / Solar cell based irradiation sensor (along with calibration certificate) provided, with the sensor mounted in the plane of the array. Readout integrated with data logging system.
- iv. Temperature: Temperature probes for recording the Solar panel temperature and/or ambient temperature to be provided complete with readouts integrated with the data logging system
- v. The following parameters are accessible via the operating interface display in real time separately for solar power plant:
  - a. AC Voltage.
  - b. AC Output current.
  - c. Output Power
  - d. Power factor.
  - e. DC Input Voltage.
  - f. DC Input Current.
  - g. Time Active.
  - h. Time disabled.
  - i. Time Idle.
  - j. Power produced
  - k. Protective function limits (Viz-AC Over voltage, AC Under voltage, Over frequency, Under frequency ground fault, PV starting voltage, PV stopping voltage.
- vi. All major parameters available on the digital bus and logging facility for energy auditing through the internal microprocessor and read on the digital front panel at any time) and logging facility (the current values, previous values for up to a month and the average values) should be made available for energy auditing through the internal microprocessor and should be read on the digital front panel.
- vii. PV array energy production: Digital Energy Meters to log the actual value of AC/ DC voltage, Current & Energy generated by the PV system provided. Energy meter along with CT/PT should be of 0.5 accuracy class.
- viii. Computerized DC String/Array monitoring and AC output monitoring shall be provided as part of the inverter and/or string/array combiner box or separately.
- ix. String and array DC Voltage, Current and Power, Inverter AC output voltage and current (All 3 phases and lines), AC power (Active, Reactive and Apparent), Power Factor and AC energy (All 3 phases and cumulative) and frequency shall be monitored.
- x. Computerized AC energy monitoring shall be in addition to the digital AC energy meter.
- xi. The data shall be recorded in a common work sheet chronologically date wise. The data file shall be MS Excel compatible. The data shall be represented in both tabular and graphical form.
- xii. All instantaneous data shall be shown on the computer screen.
- xiii. Software shall be provided for USB download and analysis of DC and AC parametric data for individual plant.

- xiv. Provision for Internet monitoring and download of data shall be also incorporated.
- xv. Remote Server and Software for centralized Internet monitoring system shall be also provided for download and analysis of cumulative data of all the plants and the data of the solar radiation and temperature monitoring system.
- ~~xvi. Solar Radiation and Environment Monitoring System~~
- ~~xvii. Computerized solar radiation and environment monitoring system shall be installed on one of the buildings along with the solar PV power plant.~~
- ~~xviii. The system shall consist of various sensors, signal conditioning, data acquisition, LCD display and remote monitoring.~~
- ~~xix. Global and diffuse beam solar radiation in the plane of array (POA) shall be monitored on continuous basis.~~
- ~~xx. Ambient temperature and relative humidity near PV array, control room temperature, at the level of array plane shall be monitored on continuous basis.~~
- xxi. Ambient / Solar PV module back surface temperature shall be also monitored on continuous basis.
- xxii. Simultaneous monitoring of DC and AC electrical voltage, current, power, energy and other data of the plant for correlation with solar and environment data shall be provided.
- ~~xxiii. Solar radiation and environment monitoring system shall have real time clock, internal reliable battery backup and data storage capacity to record data round the clock for a period of min. 1 year.~~
- ~~xxiv. The data shall be recorded in a common work sheet chronologically date wise. The data file should be MS Excel compatible. The data shall be represented in both tabular and graphical form.~~
- ~~xxv. All instantaneous data shall be shown on the computer screen.~~
- ~~xxvi. Historical data shall be available for USB download and analysis.~~
- ~~xxvii. Provision for Internet monitoring and download of data shall be incorporated.~~
- xxviii. Remote Monitoring and data acquisition through Remote Monitoring System software at the owner /SECI location with latest software/hardware configuration and service connectivity for online / real time data monitoring/control complete to be supplied and operation and maintenance/control to be ensured by the supplier. Provision for interfacing these data on SECI server and portal in future shall be kept.

**23. TRANSFORMER “IF REQUIRED” & METERING:**

- a) Dry/oil type relevant kVA, 11kV/415V, 50 Hz Step up along with all protections, switchgears, Vacuum circuit breakers, cables etc. along with required civil work.
- b) The bidirectional electronic energy meter (0.5 S class) shall be installed for the measurement of import/Export of energy.
- c) The bidder must take approval/NOC from the Concerned DISCOM for the connectivity, technical feasibility, and synchronization of SPV plant

with distribution network and submit the same to SECI before commissioning of SPV plant.

- d) Reverse power relay shall be provided by bidder (if necessary), as per the local DISCOM requirement.

**24. POWER CONSUMPTION:**

- a) Regarding the generated power consumption, priority need to give for internal consumption first and thereafter any excess power can be exported to grid. Finalization of tariff is not under the purview of SECI or MNRE. Decisions of appropriate authority like DISCOM, state regulator may be followed.

**25. PROTECTIONS**

The system should be provided with all necessary protections like earthing, Lightning, and grid islanding as follows:

**25.1. LIGHTNING PROTECTION**

- a) The SPV power plants shall be provided with lightning & overvoltage protection. The main aim in this protection shall be to reduce the over voltage to a tolerable value before it reaches the PV or other sub system components. The source of over voltage can be lightning, atmosphere disturbances etc. The entire space occupying the SPV array shall be suitably protected against Lightning by deploying required number of Lightning Arrestors. Lightning protection should be provided as per IEC 62305 standard. The protection against induced high-voltages shall be provided by the use of metal oxide varistors (MOVs) and suitable earthing such that induced transients find an alternate route to earth.

**25.2. SURGE PROTECTION**

- a) Internal surge protection shall consist of three MOV type surge-arrestors connected from +ve and –ve terminals to earth (via Y arrangement)

**25.3. EARTHING PROTECTION**

- a) Each array structure of the PV yard should be grounded/ earthed properly as per IS:3043-1987. In addition the lightning arrester/masts should also be earthed inside the array field. Earth Resistance shall be tested in presence of the representative of Department/SECI as and when required after earthing by calibrated earth tester. PCU, ACDB and DCDB should also be earthed properly.
- b) Earth resistance shall not be more than 5 ohms. It shall be ensured that all the earthing points are bonded together to make them at the same potential.

**25.4. GRID ISLANDING:**

- a) In the event of a power failure on the electric grid, it is required that any independent power-producing inverters attached to the grid turn off in a short period of time. This prevents the DC-to-AC inverters from continuing to feed power into small sections of the grid, known as “islands.” Powered islands present a risk to workers who may expect the area to be unpowered, and they may also damage grid-tied equipment. The Rooftop PV system shall be equipped with islanding protection. In addition to disconnection from the grid (due to islanding protection) disconnection due to under and over voltage conditions shall also be provided.
- b) A manual disconnect 4pole isolation switch beside automatic disconnection to grid would have to be provided at utility end to isolate the grid connection by the utility personnel to carry out any maintenance. This switch shall be locked by the utility personnel

## 26. CABLES

Cables of appropriate size to be used in the system shall have the following characteristics:

- i. Shall meet IEC 60227/IS 694, IEC 60502/IS1554 standards
- ii. Temp. Range:  $-10^{\circ}\text{C}$  to  $+80^{\circ}\text{C}$ .
- iii. Voltage rating 660/1000V
- iv. Excellent resistance to heat, cold, water, oil, abrasion, UV radiation
- v. Flexible
- vi. Sizes of cables between array interconnections, array to junction boxes, junction boxes to Inverter etc. shall be so selected to keep the voltage drop (power loss) of the entire solar system to the minimum. The cables (as per IS) should be insulated with a special grade PVC compound formulated for outdoor use.
- vii. Cable Routing/ Marking: All cable/wires are to be routed in a GI cable tray and suitably tagged and marked with proper manner by good quality ferule or by other means so that the cable easily identified.
- viii. The Cable should be so selected that it should be compatible up to the life of the solar PV panels i.e. 25years.
- ix. The ratings given are approximate. Bidder to indicate size and length as per system design requirement. All the cables required for the plant provided by the bidder. Any change in cabling sizes if desired by the bidder/approved after citing appropriate reasons. All cable schedules/layout drawings approved prior to installation.
- x. Multi Strand, Annealed high conductivity copper conductor PVC type ‘A’ pressure extruded insulation or XLPE insulation. Overall PVC/XLPE insulation for UV protection Armoured cable for underground laying. All cable trays including covers to be provided. All cables conform to latest edition of IEC/ equivalent BIS Standards as specified below: BoS item / component Standard Description Standard Number Cables General Test and Measuring Methods, PVC/XLPE insulated cables for working

Voltage up to and including 1100 V ,UV resistant for outdoor installation IS /IEC 69947.

- xi. The size of each type of DC cable selected shall be based on minimum voltage drop however; the maximum drop shall be limited to 1%.
- xii. The size of each type of AC cable selected shall be based on minimum voltage drop however; the maximum drop shall be limited to 2 %.

## 27. CONNECTIVITY

The maximum capacity for interconnection with the grid at a specific voltage level shall be as specified in the Distribution Code/Supply Code of the State and amended from time to time. Following criteria have been suggested for selection of voltage level in the distribution system for ready reference of the solar suppliers.

<b>Plant Capacity</b>	<b>Connecting voltage</b>
Up to 10 kW	240V-single phase or 415V-three phase at the option of the consumer
Above 10kW and up to 100 kW	415V – three phase
Above 100kW	At HT/EHT level (11kV/33kV/66kV) as per DISCOM rules

- a) The maximum permissible capacity for rooftop shall be 1 MW for a single net metering point.
- b) Utilities may have voltage levels other than above, DISCOMS may be consulted before finalization of the voltage level and specification be made accordingly.
- c) For large PV system (Above 100 kW) for commercial installation having large load, the solar power can be generated at low voltage levels and stepped up to 11 kV level through the step up transformer. The transformers and associated switchgear would require to be provided by the SPV bidders.

## 28. TOOLS & TACKLES AND SPARES:

- a) After completion of installation & commissioning of the power plant, necessary tools & tackles are to be provided free of cost by the bidder for maintenance purpose. List of tools and tackles to be supplied by the bidder for approval of specifications and make from SECI/ owner.
- b) A list of requisite spares in case of PCU/inverter comprising of a set of control logic cards, IGBT driver cards etc. Junction Boxes. Fuses, MOVs / arrestors, MCCBs etc along with spare set of PV modules be indicated,

which shall be supplied along with the equipment. A minimum set of spares shall be maintained in the plant itself for the entire period of warranty and Operation & Maintenance which upon its use shall be replenished

**29. DANGER BOARDS AND SIGNAGES:**

- a) Danger boards should be provided as and where necessary as per IE Act. /IE rules as amended up to date. Three signage shall be provided one each at battery –cum- control room, solar array area and main entry from administrative block. Text of the signage may be finalized in consultation with SECI/ owner.

**30. FIRE EXTINGUISHERS:**

The firefighting system for the proposed power plant for fire protection shall be consisting of:

- a) Portable fire extinguishers in the control room for fire caused by electrical short circuits
- b) Sand buckets in the control room
- c) The installation of Fire Extinguishers should confirm to TAC regulations and BIS standards. The fire extinguishers shall be provided in the control room housing PCUs as well as on the Roof or site where the PV arrays have been installed.

**31. DRAWINGS & MANUALS:**

- a) Two sets of Engineering, electrical drawings and Installation and O&M manuals are to be supplied. Bidders shall provide complete technical data sheets for each equipment giving details of the specifications along with make/makes in their bid along with basic design of the power plant and power evacuation, synchronization along with protection equipment.
- b) Approved ISI and reputed makes for equipment be used.
- c) For complete electro-mechanical works, bidders shall supply complete design, details and drawings for approval to SECI/owners before progressing with the installation work

**32. PLANNING AND DESIGNING:**

- a) The bidder should carry out Shadow Analysis at the site and accordingly design strings & arrays layout considering optimal usage of space, material and labor. The bidder should submit the array layout drawings along with Shadow Analysis Report to SECI/Owner for approval.
- b) SECI reserves the right to modify the landscaping design, Layout and specification of sub-systems and components at any stage as per local site conditions/requirements.
- c) The bidder shall submit preliminary drawing for approval & based on any modification or recommendation, if any. The bidder submit three sets and soft copy in CD of final drawing for formal approval to proceed with construction work.

### **33. DRAWINGS TO BE FURNISHED BY BIDDER AFTER AWARD OF CONTRACT**

- a) The Contractor shall furnish the following drawings Award/Intent and obtain approval
- b) General arrangement and dimensioned layout
- c) Schematic drawing showing the requirement of SV panel, Power conditioning Unit(s)/ inverter, Junction Boxes, AC and DC Distribution Boards, meters etc.
- d) Structural drawing along with foundation details for the structure.
- e) Itemized bill of material for complete SV plant covering all the components and associated accessories.
- f) Layout of solar Power Array
- g) Shadow analysis of the roof

### **34. SOLAR PV SYSTEM ON THE ROOFTOP FOR MEETING THE ANNUAL ENERGY REQUIREMENT**
